UNOPPOSED MOTION FOR DISMISSAL OF PETITION

Respondents Ernest L. Duran, Jr., and Bradley Johnston (correct spelling, rather than "Johnson" as in official caption), as the Proponents of Proposed Initiative 2007-2008 #96 (hereinafter "Proponents"), by and through their counsel Berenbaum, Weinshienk & Eason, P.C., move for entry of an order dismissing the Petition. As grounds for this motion, Proponents state as follows:

- 1. On May 27, 2008, Petitioner filed his Petition for Review of Final Action of Ballot Title Setting Board Concerning Proposed Initiative #96 (unofficially captioned by legislative staff for tracking purposes, "Cost-of-Living Wage Increase") ("Initiative #96").
- 2. On June 17, 2008, the Proponents withdrew Initiative #96. See letter to Mike Coffman, Colorado Secretary of State, dated June 17, 2008, attached as Exhibit 1.
- 3. Proponents' withdrawal of Initiative #96 moots the issues framed by the Petition.
- 4. Counsel for the Proponents conferred with counsel for the Petitioner and counsel for the Title Board about this motion. Neither counsel for the Petitioner nor counsel for the Title Board objects to the dismissal of the Petition.

WHEREFORE, Proponents move for entry of the Court's order dismissing the Petition.
