FISCAL YEAR 2023 PERFORMANCE PLAN

NOVEMBER 1, 2022

The legitimacy of government depends on the fair, impartial, and reliable administration of the laws. Courts serve the people of the state by resolving disputes, protecting individual rights and the public interest, and delivering justice in criminal and civil cases. To ensure a just society, courts must tailor the fair, effective, and efficient delivery of justice to fit each individual case.

For citizens to trust the judicial system they must believe that justice is truly for all. The courts are a fundamental government service and should be easily accessible by the public.

Mission

The Colorado Judicial Department, comprised of our state Courts and Probation Services, provides a fair and impartial system of justice that:

Protects constitutional and statutory rights and liberties;

Assures equal access;

Provides fair, timely and constructive resolution of cases;

Enhances community welfare and public safety;

Supervises offenders; and

Facilitates victim and community reparation.

STATUTORY AUTHORITY: The authority for Colorado's Courts is at Article VI, Colo. Const. and §13-4-101, C.R.S.; and for Probation Services is at §§18-1.3-201 and 18-1.3-202.

Major Functions of the Department

COLORADO SUPREME COURT

The Colorado Supreme Court is the state's court of last resort. Decisions are binding on all other Colorado state courts. The Supreme Court is composed of seven justices who serve ten-year terms, and the Chief Justice is selected from the membership of justices. The Chief Justice also serves as the executive head of the Colorado Judicial System and is the ex-officio chair of the Supreme Court Nominating Commission. The Chief Justice appoints the Chief Judge of the Court of Appeals and the Chief Judge of each of the state's 22 judicial districts (including Denver Juvenile and Denver Probate, which are separate courts in the 2nd Judicial District, each with their own Chief Judge) and is vested with the authority to assign judges (active or retired) to perform judicial duties.

Requests to review decisions of the Colorado Court of Appeals constitute a majority of the Supreme Court's filings. The Supreme Court also has direct appellate jurisdiction over cases in which a statute has been held to be unconstitutional, cases involving decisions of the Public Utilities Commission, writs of habeas corpus, cases involving adjudication of water rights, summary proceedings initiated under the Election Code, and prosecutorial appeals concerning search and seizure questions in pending criminal proceedings. All of these appeals are filed directly with the Supreme Court, and, in these cases bypass the Court of Appeals. The Supreme Court also has exclusive jurisdiction to promulgate rules governing practice and procedure in civil and criminal actions.

Colorado's attorneys are licensed and disciplined by the Supreme Court. The court's attorney regulation system, funded by attorney registration fees, helps the Colorado Supreme Court regulate the practice of law in Colorado through various programs. The office oversees attorney admissions, attorney registration, mandatory continuing legal and judicial education, attorney diversion and discipline, regulation of the unauthorized practice of law, and inventory counsel. In addition, the court oversees the State Court Administrator, Board of Continuing Legal Education and the Board of Law Examiners.

COLORADO COURT OF APPEALS

The Colorado Court of Appeals is the state's intermediate appellate court and consists of 22 judges who serve eight-year terms. The Court sits in three-member divisions to decide cases. The mission of the Court of Appeals is to provide the citizens of Colorado with clear, impartial, and timely resolutions of appealed orders and judgments as provided by law. The Court of Appeals has initial jurisdiction, with exceptions, over appeals from the Colorado District Courts, Denver Probate Court, and Denver Juvenile Court. In addition, the Court of Appeals has appellate jurisdiction over decisions originating from several state administrative boards and agencies. Review of the Court of Appeals' decisions are directed to the Colorado Supreme Court.

COLORADO TRIAL COURTS

Established pursuant to Article VI of the Colorado Constitution, Colorado's state trial courts consist of county courts, district courts, and water courts. Colorado is divided into 22 judicial districts. District boundaries generally align with county borders; however, except for four districts, most districts are comprised of multiple counties. There are currently 196 district judges serving within Colorado's 22 judicial districts. District judges preside over felony criminal matters, civil claims in any amount, juvenile

matters (including adoption, dependency and neglect matters, juvenile delinquency, and paternity actions), probate, mental health, divorce proceedings, and water cases. Additionally, district judges handle appeals from Colorado municipal and county courts, and review decisions of some administrative boards and agencies. Within the 2nd Judicial District, Denver Juvenile and Denver Probate courts operate independently from the District Court. These two courts have limited jurisdiction over juvenile and probate matters respectively.

Colorado's county courts serve the citizens of each county in the state. County judges handle cases involving serious public safety issues such as misdemeanor cases, felony advisements, setting bonds, and preliminary hearings. There are 114 county court judges. County judges also issue restraining orders in cases involving domestic violence arrest, issue search warrants, and preside over traffic cases and civil actions involving no more than \$25,000.

The Water Right Determination and Administration Act of 1969 created seven water divisions according to drainage patterns of various rivers in Colorado. Each water division is staffed with a division engineer, appointed by the state engineer; a water judge, appointed by the Supreme Court; a water referee, appointed by the water judge; and a water clerk, assigned by the district court. Water judges are district judges appointed by the Supreme Court and have jurisdiction in the determination of water rights, the use and administration of water, and all other water matters within the jurisdiction of the water divisions.

PROBATION SERVICES

Adult and juvenile probation supervision is provided in all 22 of Colorado's judicial districts. This includes 23 probation departments with over 70 separate probation offices throughout the state. Probation also provides victim services and writes presentence investigation reports for Colorado's Courts. Probation continues to work to identify and utilize assessments, processes, and programs that enhance public safety, are cost effective and lead to positive outcomes for the probationer and the community.

OFFICE OF THE STATE COURT ADMINISTRATOR

Colorado Courts and Probation, with more than 300 judges and 3,600 support staff members, is centrally administered by the Chief Justice of the Supreme Court. To assist the Chief Justice, the Supreme Court appoints the State Court Administrator (SCA). Each of the State's 22 Judicial Districts (and Denver Juvenile and Denver Probate courts) also has a Court Executive and a Chief Probation Officer, and each of the 64 counties has a Clerk of Court.

The State Court Administrator's Office (SCAO) provides administrative support and services to the trial courts, appellate courts, and probation to assist them in providing the citizens of Colorado meaningful, speedy and economical forums to resolve disputes. It also supports the management of probation services to enhance public safety and offender rehabilitation.

In executing its constitutional and statutory duties, the office has the following functions: to provide administrative and technical support to the appellate courts, trial courts and probation; to provide centralized policy guidance; to develop and implement standards and guidelines; to serve as an advocate in obtaining necessary resources from the legislature; to provide services in an accurate, timely and equitable manner. Business processes and technologies are consistently under evaluation for improvements throughout the Department in order to improve efficiency and to make the courts more accessible to the citizens of Colorado.

Principle Strategies & Goals

PRINCIPLE 1: Provide equal access to the legal system and give all an opportunity to be heard.

Barriers to access range from difficulties navigating court and probation facilities to a lack of information on how to obtain accommodations for people with disabilities or those with limited English proficiency to inadequate resources to assist self-represented parties with their procedural questions. Such barriers may compromise effective and meaningful access to the court system.

GOAL 1a. Identify and address barriers to effective participation.

GOAL 1b. Maintain safety in all court and probation facilities.

GOAL 1c. Assist self-represented parties.

PRINCIPLE 2: Treat all with dignity, respect, and concern for their rights and cultural backgrounds, and without bias or appearance of bias.

As Colorado's population continues to diversify, so does the population that participates in the court system. It is important that judges and judicial staff be aware of the values of a wide number of cultures and life experiences, and, when appropriate, make accommodations. Courts and Probation are working to ensure that the courts are free from both bias and the appearance of bias, meeting the needs of increasing numbers of self-represented litigants, remaining receptive to the needs of all constituents, ensuring that court procedures are fair, understandable and accessible, and providing culturally responsive programs and services.

GOAL 2a. Collect feedback from court users, victims of crime, and those on probation regarding their experience with court and probation services.

GOAL 2b. Train all court and probation employees in communication, cultural competency, and customer service skills.

PRINCIPLE 3: Promote quality judicial decision-making and judicial leadership.

Court practices and case management procedures should be as uniform as practicable to avoid confusion and uncertainty. Courts and Probation must provide ongoing professional development, education, and training to address many concerns including the increasing complexity of court practices and procedures in court operations and interactions with the public. Maintaining professional excellence will promote public trust and confidence in the judicial system as a whole.

GOAL 3a. Employ effective case management strategies.

GOAL 3b. Incorporate evidence-based principles in judicial decision-making.

GOAL 3c. Employ accountability methods to ensure court orders are being enforced and monitored.

GOAL 3d. Develop systems that assure court-appointed persons are providing quality services.

GOAL 3e. Train and educate judicial officers on an ongoing basis.

GOAL 3f. Implement professional development and leadership programs for staff.

PRINCIPLE 4: Implement quality assessments and community supervision of adult and juvenile probationers to demonstrably enhance public safety and respect for victim rights. The Division of Probation Services strives to reduce offender recidivism through the application of the Eight Principles of Effective Intervention. Probation Services promotes accountability and responsiveness in its enforcement of the court's orders while affecting long-term behavior change in offenders.

GOAL 4a. Ensure the accuracy and efficiency of pre- and post-sentence assessments; and provide comprehensive assessment information to assist judicial officers in making more informed decisions, leading to improved and less costly outcomes.

GOAL 4b. Employ evidence-based practices in all applicable areas of probation.

PRINCIPLE 5: Cultivate public trust and confidence through the thoughtful stewardship of public resources.

In serving the people of Colorado, Courts and Probation must also exercise its constitutional and statutory authority and responsibility to plan for, direct, monitor, and support the business of the system and to account to the public for the system's performance. The fulfillment of this role is only possible when the other branches of government and the public have trust and confidence in the system. In order to retain trust and confidence, the system must be accountable to the people it serves by providing a fair and open process, communicating clear and consistent expectations for all who participate in that process, and being good stewards of the resources appropriated to it for the fulfillment of its mission.

GOAL 5a. Utilize the most effective and cost-efficient methods to conduct the business of the courts and probation.

GOAL 5b. Employ new and enhanced technology solutions for managing judicial business.

GOAL 5c. Share information and data with other governmental entities and the public, while balancing privacy and security concerns.

GOAL 5d. Ensure transparency of court and probation services operations.

GOAL 5e. Maintain a strong and well-trained workforce.

Environmental Scan

In fiscal year 2022 (FY22), the Judicial Department made some significant strides addressing the backlog of work that accumulated since the onset of the COVID-19 public health crisis in 2020. Unfortunately, the increased turnover rate that the Department experienced in FY21 continued in FY22, with an overall staff turnover rate that exceeded 15%. The trial courts had an especially high staff turnover rate of over 20%. This means that the staff who are supporting trial court case management and processing are significantly less experienced than they were a few years ago. Having less experienced staff implementing numerous legislatively driven work adaptations is most certainly putting significant strain on the courts. In addition, recruitment continues to be challenging. The SCAO's Human Resources Division reports that there were over 1,000 positions recruited in the Judicial Department in calendar year 2021 and as of mid-October, about 785 positions have posted in the Department in 2022. This is compared to fewer than 300 positions posted in 2020. Despite having many more positions available, the Department is seeing significantly fewer applicants for these jobs. In fact, the number of total applications received annually has been steadily declining since 2019 when it received 25,723 applications; in 2021, the Department received 16,286 applications, and through the first 10 ½ months of 2022, it has received just 12,125 applications. As a result, the Department is recruiting for more positions but receiving far fewer applicants from which to choose.

The Department was involved in various phases of implementation for a number of significant initiatives, including:

- Implementing the legislation that requires the courts to conduct a bond hearing within 48 hours of a person arriving at a detention facility (House Bill 21-1280)
- Working to establish the 23rd Judicial District in January 2025 as required by House Bill 20-1026
- Developing and piloting a revised Court User Survey to solicit feedback from public and professional court users (e.g., parties to cases, attorneys, law enforcement, etc.)
- Modernizing its case and person management system
- Updating the district court judge weighted caseload model
- Continuing to increase diversity on the trial court bench
- Improving various juvenile probation practices as required by Senate Bill 19-108

Finally, the Department also worked to prioritize and address several concerns that were identified in various investigative reports. The leadership of the Colorado Judicial Department is deeply committed to a progressive and people centered organization. Much of the last three years has been focused on building and rebuilding basic organizational structures where fundamental systems were not existent or produced inconsistent processes and outcomes. The first step of developing a person-centered culture and organization is currently underway with the Supreme Court engaging directly with Judicial staff to develop and re-imagine the Department's mission, goals and necessary workplace changes not to mention to understand first-hand the employee experience across the state. The Judicial Department is committed to investing in a healthy and thriving workplace with the values of respect, integrity, ethical behavior, inclusivity, and accountability as part of everything we do.

Immediate areas of focus will be:

 Development and delivery of Inclusion, Diversity, Equity and Accessibility (IDEA) programs and resources.

- Modernizing the Branch's Human Resources Department into a progressive, people-centered
 office which includes adding critical components for employee support, safety and resources that
 were severely limited by capacity and are necessary to develop decision making protocols
 centered on the person. Establishment of an Ombudsperson and reporting mechanisms for
 employees that support a safe space for individuals to seek advice, share concerns and connect
 to resources that meet their needs and goals is one example.
- Development and delivery of trainings supporting a workplace grounded in shared values and a healthy and holistic culture such as Inclusion, Diversity, Equity, and Accessibility; Respectful Workplace; Anti-Bullying; Bystander Awareness and Assertiveness; Management Training for employees and judicial officers; Leadership Development; Managing Conflict; and Communication.
- Assessment of existing trainings offered by the organization to ensure content and delivery are consistent with the organization's values.
- Policy and process development to formalize the work on organizational culture and affirm the commitment to our values; to include amending or establishing new policies to have a stronger reflection of the cultural and behavioral expectations of employees and judicial officers, creating processes to ensure all members of the organization understand and agree to these expectations and develop accountability processes.

Education in the Courts & Probation

Staff and judicial officer training continues to be a critical need for the Judicial Department. Judicial trainers continue to use research-based approaches to facilitate learning. These techniques are designed to give training participants a more balanced approach to learning and to increase content retention and skill development. Extensive planning and attention to evidence-based approaches to learning are utilized to maximize learning and skill development.

Some education-related needs have been restored following cuts made in 2020 and 2021. The Judicial Conference is a key training opportunity for judicial officers. After the funding for the conference was cut for FY21 and FY22, leading to virtual conferences both years, the Judicial Conference returned to an inperson format in FY23 and was held in September. In addition, funding for the Colorado Institute for Faculty Excellence (COIFE) has been restored and will take place in April and October of 2023. These efforts support judges, probation and trial court staff in their ongoing education and leadership development needs. Further, COIFE has historically served as a laboratory for the creation and implementation of initiatives and solutions that further the mission and goals of the Judicial Department. One durable and effective example of this is the Peer-to-Peer coaching program for judicial officers.

Despite some progress, areas of significant unmet needs continue to exist related to training and education of staff. Specifically, the Court Education Specialist position that was lost during the 2020 budget cuts has yet to be restored. The Court Education Specialist position is a key resource the trial courts rely on to provide training on critical aspects of trial court staff work, such as data entry of warrants, court orders, sentences, and other sensitive data. Currently, a team of eight Court Education Specialists support the vast majority of trial court staff training for approximately 1,855 trial court staff in all 64 counties and 22 judicial districts across the state. Trial court education continues to utilize a hybrid training plan that includes instructor-led virtual training, on demand modules, and in-person training. In the last year, 521 formal classes were offered. Additionally, 543 individualized trainings were conducted for employees and judges, generally provided for those who were either new to the branch or new to their position. The Court Education Specialists also provided 56, six-hour new employee orientations

going over the basics of case management systems and applications. The trial courts also utilize distance learning modules to help support training needs of the districts with on-demand training when possible. Although the Court Education Specialist program has leveraged all available resources and modalities to maximize existing resources, some training needs continue to suffer due to insufficient resources. More than 1,000 new trial court employees (excluding judges) have joined the Judicial Department in the past two years. The influx of new employees has significantly increased the demand for training, particularly individualized and in-person training, to support new employees with the more complex and fast-paced aspects of the work.

Training is also a focus for probation staff. In addition to the required training delivered statewide by the Professional Development Unit in the Division of Probation Services, skill training is being delivered to probation staff for several research-informed programs and practices. A specific focus includes the development of coaching skills for supervisors through various practice opportunities (e.g., at the Probation Academy, Strategies for Behavior Change, and Orientation to Supervision). This is intended to help supervisors support probation staff as they implement best- and research-informed practices. More educational experiences for leadership development are also being explored.

Probation officers are also trained in assessment and case planning. A total of 22 local trainers exist to provide on-going booster trainings, complement training from the state office, and ensure on-going attention to high-fidelity assessments and case plans. The Division of Probation Services (DPS), in collaboration with the local trainers and trainers from partner agencies, continue to improve upon assessment and case planning training by integrating more technology and distance learning components. The ability to use web conferencing technology has allowed learning and practice to occur with staff from all areas of the state without the need to leave their local office. Additionally, collaborative efforts over web conference have helped in re-imagining the infrastructure of assessment and case planning learning as well as the development of new learning tools and resources.

Probation is providing training and ongoing support and technical assistance for brain injury screening to four probation departments. Probation collaborates with the courts and other agency stakeholders to research, implement, train, and provide technical assistance for brain injury screening efforts for justice-involved adults and juveniles across the state.

Senior Judge Program Expansion

The Senior Judge Program continues to be vital to the trial courts in addressing backlogged cases and delays in case processing due to the pandemic. At the request of the trial courts, the Senior Judge Program assigns senior judges to hear cases in which the trial judges have recused themselves for reasons set forth by §13-1-122, C.R.S.; or so the court's docket is not interrupted to the detriment of the litigants due to the illness or unexpected absence of a judge, judicial vacancy, judicial training and education, or an overscheduled docket when a judicial officer is double set with trials or other docket matters. In 2021, the program resources were increased to further support these efforts via HB21-1136. The program added seven new senior judge contracts between November 1, 2021, and October 1, 2022, representing an increase in 300 senior judge contract days to be utilized in the trial courts and 60 senior judge contract days in the appellate courts. The program will continue to add new senior judge contracts in the months to come as additional retirees become available to serve. In the month of September, the senior judges provided more than 1,800 hours of coverage for courts across the state. This means that on any given workday, there are roughly seven senior judges providing coverage to the trial courts across the state.

Between January 2021 and September 2022, senior judges covered 120 trials in 19 different judicial districts. This number represents trials presided over by a senior judge. In addition, senior judges support trial courts addressing the backlog of trials by covering dockets to allow sitting judges to handle trials. While we do not have a way to measure the volume of this coverage, the number of coverage days provided monthly suggests it is significant.

48-Hour Bond Hearing Implementation

House Bill 21-1280 was passed in 2021, with an effective date of April 1, 2022. Among other things, the bill required the courts to hold a bond hearing within 48 hours of a person's arrival at a detention facility. This means that the courts must conduct this work on weekends and holidays, which is a significant shift for the vast majority of court locations statewide. Adding days of the week that courts must conduct proceedings has created staffing challenges and loss of efficiencies in processes that trial courts previously relied upon.

The appropriation that came with the legislation provided funding to establish two regional bond hearing offices. These offices use bond hearing magistrates to conduct bond hearings for persons arrested in multiple judicial districts. Given the regionalization of these offices, all hearings are conducted virtually, using a Webex platform, and live-streamed via the Judicial Department's website. Standing up these two bond hearing offices requires significant and on-going coordination with multiple jails, district attorney's offices, and public defenders.

Between April 1, and September 30, 2022, a total of 4,097 bond hearings were conducted on a weekend or holiday¹, with 1,320 bond hearings conducted in the two bond hearing offices, and an additional 2,777 bond hearings conducted by judicial officers in districts that are not part of a bond hearing office. Further, in 2,253 cases, the bond that was set on a weekend or holiday was posted within one day. It is reasonable to assume that many individuals who had a bond set on a weekend or holiday experienced less disruption to their employment and family obligations than they would have experienced prior to the implementation of this legislation.

While decreasing the amount of time that an accused person spends in jail is an important benefit, there is still work to be done to ensure the trial courts can sustain the significant systemic changes that are required to accomplish these efforts. To that end, the SCAO continues to contribute significant staff resources and energy toward working with judicial districts statewide to develop options that would alleviate and minimize this strain. Such efforts include conducting a process evaluation to determine the extent to which the requirements of HB21-1280 have been implemented statewide, to assess the efficiency and effectiveness of the bond hearing offices, and to determine what additional resources are needed to sustain the requirements of HB21-1280. Preliminary findings in the first phase of this evaluation suggest that even with the initial appropriation provided with the passage of HB21-1280, the impact of adding working days for trial courts has put significant strain on trial court staff statewide. In fact, because there is additional interest from court locations to join a bond hearing office, and because the two existing offices are already struggling to accommodate the current volume of cases, the Judicial Department will need to stand up a third bond hearing office as soon as resources are available.

¹ One judicial district is missing from this data. That district, which is not part of a bond hearing office, reports conducting 1,044 weekend / holiday bond hearings during the first six months of implementation. The number of bonds posted within one day of a weekend or holiday bond hearing is currently unavailable for this district, but it is assumed the 2,253 bonds posted is an under-estimate of the actual number of bonds posted within one day.

Furthermore, a supervision gap exists for trial court staff doing this weekend and holiday work, meaning that because of the limited trial court supervisor resources statewide, weekend and holiday supervision is falling to a relatively small number of people, further straining an already stretched workforce. Lastly, it may be reasonable to assume that asking court staff to work undesirable shifts on weekends and holidays will only exacerbate the already challenging turnover and recruitment environment described above.

23rd Judicial District Implementation

The 23rd Judicial District project to establish Douglas County, Elbert County, and Lincoln County courts into the new 23rd Judicial District is scheduled to be effective on January 1, 2025. All judicial informational technology applications have been reviewed to determine the level of effort necessary to update or develop technical systems to support the creation of a new judicial district. The SCAO is working with the 18th Judicial District and stakeholders to understand any legislative actions necessary to staff and successfully establish the 23rd Judicial District as required. The Colorado and local bar associations have been meeting with SCAO representatives; the State Court Administrator has also met with county representatives individually and as a group on several occasions; and the 18th Judicial District leadership team has expressed interest in meeting regularly in anticipation of this transition. Of primary concern to stakeholders and judicial District are being reviewed. For informational purposes, a cost estimate for the impacted counties is included with the Judicial Department's FY24 budget request.

Court User Survey

One way that the Department assesses performance and achievement of organizational goals is by surveying court users about their experience with the courts. From FY07 through FY19, SCAO administered an in-person, paper "Access and Fairness Survey" that collected point-in-time feedback that did not always provide actionable information. The survey was temporarily halted in FY20 and FY21 due to the COVID-19 pandemic. In FY22, SCAO redesigned the survey based on extensive research on national best practices and feedback from staff. In July 2022, SCAO began piloting a revamped court user survey which requires less time for administration and produces more actionable insights. This pilot is expected to last through the end of 2022, with full statewide rollout anticipated in January 2023. Several different distribution methods are being tested during the pilot, including QR codes on signs and business cards, automatic emails to parties in cases, links on webpages, and hard copy surveys upon request. By the end of the pilot, virtual court participants will also be provided the survey link during or after virtual proceedings. Initial results indicate the revamped survey will collect a larger number of responses that local leaders can use to assess services quickly and reliably. In fact, through the end of August, and with just five districts participating in the pilot, the Department had already collected 227 responses. Automatic email distribution began in mid-August, and the Department is now collecting an average of 15 surveys per workday with this added distribution method. For context, the in-person administration method collected an average of just over 1,700 surveys each year between 2011 and 2018.

Information & Technology Services – Modernizing Case & Person Management System

The Department will be embarking on a multi-year project to modernize its case and person management system. The current homegrown system is over 25 years old and has become increasingly more difficult to maintain and modernize. Changing business practices have become more frequent, which requires a system that is highly configurable and swiftly scalable to adapt to the evolving needs of justice.

The case and person management system is critical to the daily operations of both the courts and probation. The high level of impact will require the Department to take a thoughtful, phased approach to implementing a new system. The first phase in FY23-FY24 will be to acquire consulting services to perform requirements gathering with stakeholders, build a communications plan, and create a procurement path for the case and person management system. Subsequently, the Department will need to seek funding approval to proceed with procuring the new system.

The full implementation of the system is estimated to take between five to seven years. The initial phase will be focused on the appellate courts and the probation departments throughout the state. The final phase will be to introduce the system to the trial courts.

Judicial Diversity

The Judicial Diversity Outreach (JDO) program expanded on the success of FY21 to continue to increase the number of diverse judges on the Colorado state court bench and solidify its program offerings. JDO programs focus on building a strong candidate pipeline from law students to practicing lawyers to judicial applicants. These efforts include:

- Making over 30 community presentations to various organizations in FY22, including in-person events in 9 counties.
- Through the Dream Team 2.0 Coaching Program, supporting 3 diverse applicants that were then appointed to the bench in 2022.
- Facilitating the successful Java with Judges program, which grew in popularity with diverse law students and judges.
- Partnering with the Colorado Bar Association's Underserved Areas and Legal Deserts Initiative to launch the Greater Colorado Law Student Experience pilot program that focuses on building a legal pipeline in rural communities of Colorado.

In October 2018, Colorado was left without a single Black district court judge serving in our state court system. As of the writing of this report, Colorado has 15 Black/African American judges on the state court bench, nine of whom serve at the district court level. This is remarkable progress in a four-year period. In addition, six openly LGBTQ+ judges were appointed in 2021 and 2022, including one to the Colorado Court of Appeals. Between July 1, 2021, and June 30, 2022, the Colorado Judicial Department welcomed 32 judges to the bench; 16 women judges (50% of new appointments), 3 Black/African American judges (9.4%), 1 Asian/Asian American judge (3.1%), and 4 Hispanic/Latino judges (12.5%) joined the bench.

While the number of new judges appointed to the bench over the past two years remained steady with 30 judges in FY21 and 32 judges in FY22. Judicial vacancies and appointments appear are on track to potentially exceed the prior two years in FY23 with 24 new judge appointment already by Governor's office since July 1, 2022.

The number of new diverse judges appointed since the creation of the JDO program has significantly changed the composition of the Colorado's state court bench and work remains to be done as Colorado becomes an increasingly diverse and multiracial state. As more diverse judges take the bench, equity, inclusion, and belonging remain critical to ensuring the judges' long-term success. To enhance long-term success, JDO programs supports the work of the Colorado Supreme Court Judicial Well-Being Committee and other entities working to diversify the Colorado state court bench.

Legislative Initiatives in Probation

Senate Bill 19-108

In early FY22, Probation implemented the changes mandated by the Juvenile Justice Reform (JJR) Committee which began in 2019 due to SB 19-108 (Juvenile Justice Reform). All probation officers that work with juveniles have been trained in the administration of a suite of assessments and case planning, as well as the JJR process. As of July 1, 2021, all juveniles on probation are assessed using the JJR mandated Youth Level of Service / Case Management Inventory (YLS/CMI) 2.0, the Substance Use Survey-Revised (SUS-R) and the Massachusetts Youth Screening Instrument - Version 2 (MAYSI-2). Additionally, all juvenile defendants may be ordered to complete these assessments through the new process developed by the JJR or through the long-established presentence investigation process. In FY23, Probation will review the implementation of SB19-108 to determine the success of implementation and address issues that may not be working as intended.

Pursuant to the requirement in SB19-108, the Standards for Probation in Colorado were issued by the Supreme Court on July 1, 2022, and included a section specific to juvenile cases. In June 2022, a virtual training was developed on the juvenile standards and offered to probation staff. These Standards address multiple practice changes that were driven by SB19-108, such as protocol for requesting early terminations and limiting the reasons to request a warrant for a probation violation.

Strategies for Behavior Change

Development of a structured decision-making process (known as Strategies for Behavior Change – SBC) for responding to violation behaviors and reinforcing positive behaviors with the goals of harm reduction, improved success, and long-term behavior change has been completed. The implementation of SBC has been underway for several years. In response to the requirements of SB 19-108, all juvenile probation officers have been trained in SBC or their local version of structured decision-making, in FY21. Similarly, in response to HB22-1257, the Division of Probation Services is working with local probation departments to ensure they are trained and ready to fully implement SBC, or a local version of structured decision-making, by July 1, 2023.

Management Strategies and Measurements

TRIAL COURTS

New Case Filings Overview

While the exact impacts of the COVID-19 public health crisis may still be unknown, following an overall decrease in case filings for most county and district court case classes in FY20 and FY21, filings in most case classes in county and district court increased or remained relatively stable in FY22. There are two exceptions worth noting: county court traffic case filings have now decreased for a seventh year in a row from 124,922 cases in FY15 to 88,019 cases in FY22; and district court felony criminal case filings have decreased for a third consecutive year from 56,292 cases in FY19 to 42,955 cases in FY22. Despite the decrease in felony filings overall, homicide case filings remain high and continue to require significant district court resources. Further, even though the courts are managing fewer criminal and traffic cases than a few years ago, there is evidence to suggest that the workload has not decreased proportionally. In fact, as indicated on Charts 6 through 9, the number of hearings has increased significantly compared to a few years ago.



Of concern in FY21 was the increase in filings for violent case types including homicide, assault, kidnapping, and menacing. Although that trend generally did not continue in FY22, homicide case filings remain high, with 717 cases filed in FY21 and 727 in FY22. In fact, while total district court criminal filings have decreased every year since FY19, homicide case filings have increased each year. In addition, felony theft cases increased by 11% from 6,697 cases filed in FY21 to 7,439 cases in FY22. Like the homicide case increase, theft cases have also increased consistently since FY19.







Additionally, various eviction moratoria were in place during parts of FY20 and FY21; consequently, there was a significant reduction in the number of county court forcible entry and detainer (FED) cases filed during both years, compared to FY19. However, as the restrictions on case filing have lifted, county court FED filings have once again increased.

Trial Court Management Strategies

One measure the Judicial Department utilizes to monitor workload and the ability to effectively process matters before the trial courts is to assess timeliness of proceedings. Performance goals for trial courts have been established through various means, including Chief Justice Directive 08-05 – Case Management Standards (CJD 08-05). This directive was developed with input from judges and establishes aspirational time processing goals for each case class. Information about each district's progress in meeting the goals is reported quarterly. Information for individual judges is provided to the Judicial Performance Commission during each judge's retention evaluation.

It is clear that the COVID-19 public health crisis had an impact on the timeliness of case processing. Starting in the 4th quarter of FY20 and continuing into the beginning of FY21, the percentage of cases exceeding the time processing targets established by CJD 08-05 increased for most case classes in both district and county court; in other words, more cases took longer than the target timeframe to reach disposition. However, throughout FY22, the percentage of cases exceeding the time processing targets decreased for many case classes in both district and county court, indicating that case processing times appear to be returning to pre-COVID targets.

Trial Court Backlog

As public health restrictions eased, the courts returned to a more typical jury trial schedule in FY22 and reduced the backlog of pending jury trials by more than 22%, from 14,427 in April 2021 to 11,200 in July 2022. In fact, the number of pending jury trials continued to decrease in the early months of FY23, dropping to 10,590 by the beginning of September 2022.




Chart 4: Pending Jury Trials April 2021 – September 2022

Although the 1,911 jury trials held in FY22 is still well below the number of jury trials held in either FY19 or FY18, with 2,639 and 2,702 jury trials held respectively, the courts held significantly more jury trials than FY21 (1,185) and slightly more than FY20 (1,890).





Chart 5: Jury Trials Held in County & District Court by Fiscal Year, FY18-FY22


Under existing law, a criminal defendant must be brought to trial within six months of the date of entry of a not guilty plea. House Bill (HB) 21-1309 allows the court to exclude a period of delay caused by the COVID-19 pandemic, not to exceed six months if the defendant is not in custody, or not to exceed three months if the defendant is in custody for the case pending jury trial. In compliance with statute, in January and May 2022, the Department has posted reports identifying the judicial district where each COVID continuance was granted, and the highest class of offense charged in the case. As of April 29, 2022, 262 jury trials were continued under the provisions of HB 21-1309. Of these, 127 cases had a misdemeanor charge as the highest class of offense, 113 cases had a felony as the highest class of offense, and the remaining cases had a drug felony, drug misdemeanor, or traffic offense as the highest charged offense. No additional cases were continued between May and August 2022; therefore, the report currently posted includes the most current data related to COVID continuances².

Hearings, Continuances & Failure to Appear

While filings have decreased for many case classes in county and district court, the same cannot be said for the number of hearings being scheduled. The case classes with some of the most significant decrease in filings between FY19 and FY22 are county court misdemeanor (M) and traffic (T) cases and district court criminal (CR) cases. Between FY19 and FY22, county court misdemeanor and traffic filings decreased from 174,684 filings in FY19 to 148,350 filings in FY22. This represents a 26,334 case, or 15%, decrease in filings. However, the number of scheduled events in county court misdemeanor and traffic cases jumped by 10%, or 78,623 events from 756,667 hearings in FY19 to 835,290 in FY22.

During this same timeframe, district court criminal filings went from 56,292 cases in FY19 to 42,955 cases in FY22, representing a 13,337 case, or 24%, decrease. However, although the number of scheduled events decreased from 627,326 hearings to 620,135, this 1% decrease (7,191 hearings) is disproportionate to the decrease in case filings.




Chart 7: District Court Criminal (CR) Filings and Scheduled Events

Many factors may be contributing to the increase in scheduled events, hearing continuances and party failures to appear (FTAs) may be two drivers. In district court criminal cases, the number of hearings with a failure to appear increased by 11% or 3,448 hearings, from 31,397 in FY19 to 34,845 in FY22; again, this is despite the number of district criminal case filings decreasing by 24% during that same time. In county court misdemeanor and traffic cases, while filings decreased by 15%, the number of hearings with a failure to appear increased by 31% or 22,933 hearings, from 75,144 in FY19 to 98,077 in FY22.




Chart 8: FTAs for Scheduled Events in District Criminal and County Misdemeanor & Traffic Cases, FY19-FY22

Like FTAs, continuances have increased for district court criminal and county court misdemeanor and traffic cases as well. In FY19, there were 71,335 continuances in district court criminal cases and in FY22, that number increased by 18,201 hearings, or 26% to 89,536. The increase is even more substantial in county court misdemeanor and traffic cases, which increased by 55%, or 42,942 continuances, between FY19 (77,961) and FY22 (120,903). Neither district nor county court continuance numbers cited here represent the peak continuance rate, which occurred in FY21 (see Chart 9 below).




Chart 9: Continuances for Scheduled Events in District Criminal and County Misdemeanor & Traffic Cases, FY19-FY22

These data points are significant because the workload models that are used to determine county and district court judge and trial court staff need are based on case filings. Whether due to changes in the law, adjustments due to COVID, increased rates of continuances and FTAs, or some other factor(s), there appears to be a shift in case processing that is resulting in an increase in the number of hearings scheduled for cases filed in district court criminal and county court misdemeanor and traffic case classes. If there is


an increase in hearings per case, it stands to reason that these cases may be taking more time per case than they used to. Because all three of the current workload models (district court judge, county court judge, and trial court staff) pre-date this apparent shift, it is possible that any increase in time needed per case is not accounted for in the models.

PROBATION SERVICES

Colorado Probation provides community supervision for adults and juveniles sentenced to probation. Over the last ten years, despite Colorado's general population growth, the number of individuals sentenced to probation, after peaking in FY19, has been trending downward in recent years following the COVID-19 pandemic. There were just over 1,000 more adults sentenced to probation in FY22 (35,199) compared to FY13 (34,047) and 2,500 fewer juveniles sentenced to probation in FY22 (1,451) compared to FY13 (3,992). After experiencing a sharp decline in sentences to probation during the pandemic, probation has seen a steady increase in numbers over the last 18 months as the courts addressed a backlog of criminal filings and trials.

Probation's population has experienced some interesting changes over the last decade with the introduction of diversion and early intervention programs, the implementation of recidivism reduction programs, changes in legislation and the impact of the COVID-19 pandemic on court and probation operations. Looking at the composition of probation's population, several interesting fluctuations can be noted. When looking specifically at the largest population, adults on regular supervision, the proportion of those with felony and misdemeanor has remained consistent with nearly a third of adults sentenced to probation, in any given year, have a felony conviction. After peaking in FY19 with almost 14,000 adults with felony convictions entering probation, the number has decreased in recent years. In FY22, just over 11,000 adults were sentenced to probation with a felony conviction and just over 23,500 were sentenced to probation with a misdemeanor conviction. It's likely that recent trends reflect a combination of drivers including the COVID-19 pandemic, statutory changes (e.g., the decriminalization of some drug crimes, changes in theft amounts and impaired driving offenses), and system changes to the juvenile and adult criminal justice system.

Other shifts include slight increases in the number of males and females sentenced to regular probation, while the percentage of each have remained steady: in FY13, 26% of new, regular adult probationers were female (8,713) and 74% were male (25,320), while in FY22, 25% were female (8,960) and 75% were male (26,206). Additionally, over the last ten years, the young adult regular probation population has shrunk while the remainder of the adult population (25-40+) has steadily increased. From FY13 to FY22, the percentage of probationers in the 18-24-year-old category decreased from 30% (9,388) to 17% (6,054) while the percentage of probationers in the 25-40+ range increased from 72% (24,660) to 83% (29,145).




New Adult Probationers by Gender

Alongside the trends highlighted above, probation has experienced growth in the number and proportion of higher-risk adult probationers on supervision. Leadership and staff in probation districts report that the individuals placed on probation are not only presenting with greater needs but also have more complex and disrupted stability factors (e.g., homelessness), behavioral problems, acute mental illness, and longer histories of failure on community supervision. Due to these factors, the strain placed upon state probation resources is growing. These cases require greater strategic and time-intensive supervision which exacerbate workload pressures currently felt under existing staffing levels.

Probation continues to work to identify and utilize assessments, processes and programs that uphold public safety, are cost effective, and increase positive outcomes. There is a continued focus on the identification and implementation of research-informed practices and principles. This effort is consistent with the principles of evidence-based decision-making and supports the approach of working with individuals based on their unique needs.

Probation success rates have steadily declined over the last ten years with the last three years reflecting a positive rebound. The overall success rate for probation programs in FY22 remained steady at 68%. A combination of technical violations and absconders account for most of the failures on supervision. Stability with success rates could be related to lower caseloads over the last few years. Lower caseloads help probation officers spend more time with clients to support recovery from behavioral health issues and engage in new skill development for behavior change.

As a means of providing regular performance feedback to local probation departments, each jurisdiction receives quarterly reports with individual district termination rates that allow them to monitor their progress throughout the year. Probation departments can use this information to modify local practices and programs and may request technical assistance or additional training to assist them in developing plans to improve probation practices. Probation continues to work to advance excellence in our services to clients, victims and communities with ongoing training, implementation and evaluation of programs that are aligned with best practices.

Probation Management Strategies

To improve outcomes, Probation continues to pursue the following goals: adequate staffing, implementation of applicable research-informed programs and practices, and training and skill development for staff. Probation's current efforts to improve outcomes include the following:

- Probation staff experience a significant amount of secondary trauma, due to the type of work in which they engage. The pandemic magnified the stress for these officers, as they had to find creative ways to continue providing services, while adhering to public health guidelines and local directives. In addition, the fentanyl epidemic has disproportionately affected individuals on probation, which has added another layer of distress on probation staff. In response, the Division of Probation Services (DPS) has been focusing resources on addressing staff health and wellbeing. In the past year, quarterly learning opportunities have been offered to all Judicial employees. In addition, DPS completed a pilot of the Corrections Fatigue to Fulfillment curriculum and are developing a peer support curriculum to accompany a larger rollout of the class. This is in addition to local efforts to address this issue. It is hoped that providing these resources will reduce turnover and improve the overall wellbeing of current employees, so they are better equipped to perform their job duties.
- The use of probationer typologies (a reflection of common characteristics of a group of probationers based on an analysis of Probation's adult population) has been implemented for the adult probation population and most probation staff have been trained. Intensive supervision programs were developed to specifically target higher risk probationers, with special attention to reducing their specific criminogenic needs. In FY23, an adult intensive program evaluation will be initiated to review each program and their outcomes.
- A variety of mechanisms to monitor low-risk probationers have been adopted. These efforts are costeffective, safe, and increase the amount of time that probation officers can devote to the management of higher risk offenders, without the loss of accountability for a large segment of the low-risk probation population. Examples include telephone reporting for low-risk clients, and the utilization of large low-risk only caseloads.
- The Special Projects Program (formerly known as the Rural Initiative Program) continues to facilitate the training and state approval of domestic violence, sex offender and substance abuse treatment providers in underserved counties. This effort is intended to provide quality treatment "close to home" for probationers who would otherwise be required to travel significant distances to secure treatment. More recently, navigator services have been introduced to assist probationers with successful completion of supervision and requirements of their sentence. These initiatives are supported by offender pay cash funds.
- Performance feedback efforts continue, including the development of dashboards and quarterly statistical reports summarizing each district's current population and termination numbers. These

types of information allow departments the opportunity to more quickly adapt to changing justiceinvolved populations and manage resources.

Summary

The Colorado Judicial Department continues to demonstrate tremendous resilience and adaptability as it works to implement numerous significant changes required by recent legislation, while turnover and recruitment challenges have resulted in a less experienced workforce than just a few years ago. Despite this, the Department continues to demonstrate its commitment to providing quality services to the people of Colorado. These efforts include engaging in introspective work to improve the overall culture of the Department and expanding opportunities for external court users to give their feedback about their experiences with the courts. These efforts also include ensuring that existing resources are adequate to provide the Department's high standards of service and support for its customers and its workforce. Providing adequate training for employees, having suitable recruitment and retention support, and ensuring that the administrative office can measure and advocate for the resources necessary to do the work that is required of the courts and probation statewide are all critical to the Department's overall success. These internal and external efforts will continue to result in tangible actionable improvements for the Department in pursuit of its mission to provide access to justice and ensure public safety to the communities of Colorado.

CONCERNING MEASURES RELATED TO PERMITTING CONTINUING A CRIMINAL TRIAL BECAUSE OF THE COVID-19 PANDEMIC



Report Date: May 31, 2022

SUMMARY:

Under existing law, a criminal defendant must be brought to trial within 6 months after the date of the entry of a plea of not guilty. However, there are circumstances that exclude a period of time when computing the time within which a defendant must be brought to trial. These exclusions extend the length of time within which the defendant must be brought to trial.

The act permits the court to exclude a period of delay caused by the COVID-19 pandemic, not to exceed 6 months if the defendant is not in custody for the case pending a jury trial or not to exceed 3 months if the defendant is in custody for the case pending a jury trial, if certain considerations are satisfied. The court may grant only one continuance due to a period of delay caused by the COVID-19 pandemic.

REPORT INFORMATION:

The Judicial Department shall collect the following data for each continuance granted: (I) The judicial district where the continuance was granted; and (II) The highest class offense charged in the defendant's case that was continued.

Denver County Court is not included in this report.
