A "Notice to Set Hearing" JDF 1123 is used to make an appointment with the Division Clerk to set your case for hearing before the Judge or Magistrate.

How to make your appointment: Get out a calendar, pick a day <u>at least</u> two weeks away, complete the Notice to Set Hearing (JDF 1123) form after mediation session or use "Notice to Set for Uncontested Final Order Hearing (Pro Se) (FCF 1015) for Division M, R, X, Y, and NCS.
