

6. Any required notices have been received or waived.
7. The Decedent left a Will dated 5/25/11.  
 The dates of all codicils are 6/13/12 (If there is no codicil use N/A.). The Will and any codicils are referred to as the Will. The original or e-filed copy of the duly executed, unrevoked Will is in the Registrar's possession. There are no known prior Wills which have not been expressly revoked by a later instrument. The Will is admitted to informal probate. **(Codicil is a supplement to a will.)**
