Priority – A person(s) who has first right to the appointment of Personal Representative.

Renunciation – A person who has first or equal right to the appointment of Personal representative that chooses to give up their right to appointment.

Devisee – a person named in a will to receive real or personal property of the deceased.

Decedent – Deceased.
