



ORDER SETTING NEW DEADLINES AND HEARING DATES (C-45)	

Earlier today, the Court held a status hearing during which it granted the request by the Colorado Mental Health Institute at Pueblo for additional time to complete the defendant's sanity examination and to submit a report. That impacted some of the deadlines and motions hearings previously set by the Court. Attached to this Order are the new deadlines and hearing dates which the Court proposed and the parties accepted at the hearing. The Court has included in the attachment the briefing deadlines set at the hearing on Jana Winter's motion for inspection. Additionally, the attachment includes the briefing deadlines for the supplemental submissions anticipated on the defendant's motion for sanctions and Winter's motion to quash.

By changing the deadlines and hearing dates as indicated in the attachment, the Court was able to avoid delaying the trial date. Accordingly, although the deadlines and hearing dates have changed as a result of CMHIP's request, the trial remains scheduled for February 3, 2014.
