DEFENDANT APPEARS IN CUSTODY WITH COUNSEL MS. TAMERA BRADY AND MR. DANIEL KING DDA MS. KAREN PEARSON, MR. RICH ORMAN, MR. JACOB EDSON APPEAR FOR THE PEOPLE MS. PEARSON ASKS FOR A CONTINUANCE OF THE AUGUST 23, 2012 HEARING DATE SET TO ADDRESS THE PRIVILEGE ISSUE, AND THE DEFENSE HAS NO OBJECTION TO THE PEOPLE'S REQUEST FOR A CONTINUANCE.

MR. STEVE ZWECK-BRONNER, FROM THE UNIVERSITY OF COLORADO, PRODUCES TWO SEALED COPIES OF APPROXIMATELY 100 PAGES OF NON MEDICAL EDUCATIONAL RECORDS IN RESPONSE TO THE PEOPLE'S SUBPOENA DUCES TECUM. THE COURT TAKES POSSESSION OF THE SEALED ENVELOPES AND INDICATES AN INTENTION TO CONDUCT A PRELIMINARY IN CAMERA REVIEW OF THE RECORDS WITH THE QUESTION OF RELEASE OF THE DOCUMENTS TO BE DETERMINED FOLLOWING A HEARING ON THE ISSUE. THE PEOPLE HAVE NO OBJECTION, HOWEVER, THE DEFENSE OBJECTS TO THE COURT'S IN CAMERA REVIEW OF THE DOCUMENTS AT THIS TIME. THE COURT ALLOWS THE DEFENSE UNTIL MONDAY, AUGUST 20, 2012 AT 5:00 P.M. TO FILE A WRITTEN OBJECTION TO THE COURT'S IN CAMERA REVIEW OF THE PRODUCED DOCUMENTS. DEFENSE COUNSEL WOULD LIKE TO MAINTAIN THE AUGUST 23, 2012 DATE FOR ARGUMENT REGARDING THE MOTION TO QUASH SUBPOENA DUCES TECUM, WHICH THE COURT WILL CONSIDER AS AN OBJECTION TO THE RELEASE OF THE SUBPOENAED DOCUMENTS RECEIVED BY THE COURT TODAY.

THE PEOPLE AND THE DEFENSE CURRENTLY HAVE NO OUTSTANDING SUBPOENAS DUCES TECUM AT THIS TIME, BUT COUNSEL ANTICIPATE THE NEED FOR THE ISSUANCE OF SDT'S FOR PRODUCTION OF DOCUMENTS IN THE FUTURE. THE COURT INDICATES THAT FUTURE SDT'S SHOULD INCLUDE LANGUAGE THAT WOULD REQUIRE THAT SUBPOENAED DOCUMENTS BE BATES STAMPED AS PART OF THE PRODUCTION PROCESS AND THE COURT WILL ISSUE A CASE MANAGEMENT ORDER SETTING FORTH PROCEDURE TO FOLLOW FOR FUTURE SDT RETURNS. THE COURT INVITES ARGUMENT REGARDING IMPOSITION OF A REQUIREMENT THAT ALL FUTURE ORIGINAL PLEADINGS BE ACCOMPANIED BY A REDACTED COPY OF THE PLEADING. THE PEOPLE HAVE NO OBJECTION TO THIS PROCEDURE PROVIDED THAT, IN ALL INSTANCES, BOTH THE ORIGINAL UNREDACTED VERSION IS PROVIDED TO PARTIES WITH THE REDACTED VERSION. THE DEFENSE WOULD LIKE TO RESERVE THE RIGHT TO OBJECT TO THE RELEASE OF ANY REDACTED VERSION OF ANY PLEADINGS PRIOR TO THEIR RELEASE. THE COURT WILL ALLOW THE ATTORNEYS FOR PROSECUTION AND DEFENSE THE OPPORTUNITY TO OBJECT TO THE COURT RELEASING ANY PLEADINGS FILED WITH THE COURT BEFORE DOCUMENTS ARE RELEASED TO THE PUBLIC. THE COURT ADDRESSES THE PEOPLE'S MOTION/REQUEST TO RELEASE NAMES AND CONTACT INFORMATION OF VICTIMS TO THE COLORADO ORGANIZATION FOR VICTIMS ASSISTANCE. THE DEFENSE HAS NO OBJECTION TO THE PEOPLE'S MOTION. THE COURT ENTERS A VERBAL ORDER GRANTING THE PEOPLE'S MOTION WITH AMENDMENTS, AND A WRITTEN ORDER WILL BE FORTHCOMING TODAY.

THE AUGUST 23, 2012 AT 1:30 P.M. HEARING DATE IS MAINTAINED FOR PURPOSES OF THE MOTION TO QUASH REGARDING CU RECORDS. AUGUST 30, 2012 AT 1:30 P.M. IS SET FOR HEARING ON THE PRIVILEGE ISSUE. ADDITIONAL DATE OF SEPTEMBER 20, 2012 AT 1:30 P.M. IS SET BY THE COURT FOR CASE MANAGEMENT. SEPTEMBER 27, 2012 AT 1:30 P.M. HEARING DATE IS MAINTAINED. THE WEEK OF DECEMBER 10, 2012 AT 8:30 A.M. THROUGH DECEMBER 14, 2012 IS SET FOR MOTIONS HEARING.
