DEFENDANT APPEARS IN CUSTODY WITH COUNSEL MS. TAMERA BRADY AND MR. DANIEL KINGDDA MS. KAREN PEARSON, MR. RICH ORMAN, MR. JACOB EDSON APPEAR FOR THE PEOPLE REGARDING P-16, MR. ORMAN INDICATES MOTION IS MOOT AND ASKS TO WITHDRAW P-16. FOR FUTURE REFERENCE, MR. ORMAN OFFERS THE POSITION OF THE CORONOR'S OFFICE REGARDING THOSE MATTERS REFERENCED IN P-16.  
MR. ORMAN PROVIDES ADDITIONAL ARGUMENT REGARDING P-13, INDICATING NO OBJECTION TO THE DEFENSE RECEIVING THE DOCUMENT IN QUESTION. THE COURT ORDERS THAT AT THE CONCLUSION OF TODAY'S HEARING, A REPRESENTATIVE FROM THE DEFENSE WILL MAKE A COPY OF THE DOCUMENT, IN THE DISTANT PRESENCE OF A COURT STAFF MEMBER, AND THE ORIGINAL DOCUMENT WILL REMAIN SEALED IN THE COURT'S FILE.
