# ORDER EXTENDING SUSPENSION OF JURY CALLS IN THE 19<sup>TH</sup> JUDICIAL DISTRICT THROUGH FEBRUARY 11, 2022

On December 30, 2021, I issued Administrative Order 2021-13 suspending jury calls in the 19<sup>th</sup> Judicial District through January 28, 2022. The findings and data contained in AO 2021-13 are incorporated into the present order by this reference. Included in AO 2021-13 was the COVID-19 data from the Colorado Department of Public Health and Environment ("CDPHE") website on December 30, 2021, reflecting the numbers in Weld County on that date were:

- ➤ One-Week Cumulative Incidence Rate- 302.5 (per 100,000 population);
- Two-Week Cumulative Incidence Rate- 519.9 (per 100,000 population);
- ➤ One-Week Average Positivity Rate-11.2%;
- ➤ Two-Week Average Positivity Rate- 9.4%;
- ➤ Hospitalizations- 11 (days of stable or declining new admissions).

I have included in this order data posted on the CDPHE and Weld County Public Health and Environment ("Weld Health Dept.") websites the morning of January 19, 2022, and the pertinent numbers are presently:


- ➤ One-Week Cumulative Incidence Rate- 1,490.4 (per 100,000 population);
- Two-Week Cumulative Incidence Rate- 2,978.7 (per 100,000 population);
- ➤ One-Week Average Positivity Rate- 30.6%;
- ➤ Two-Week Average Positivity Rate- 30.4%;
- ➤ Hospitalizations- 4 (days of stable or declining new admissions).

The 19th Judicial District judicial officers continue to meet weekly to discuss current COVID-19 data and operations. We most recently met on January 19, 2022. After receiving input from the judicial officers, our Court Executive, and Clerk of Court,


and review of the COVID numbers, I find that we are unable to safely assemble large numbers of persons for jury duty and that it is necessary to extend the suspension of jury calls through February 11, 2022, at a minimum.




#### One Week Cumulative Incidence Rate (CDPHE)




Two-Week Cumulative Incidence Rate (CDPHE)



## One-Week Average Positivity Rate (CDPHE)




### Two-Week Average Positivity Rate (CDPHE)




## Hospitalization Rate (CDPHE)




## Cases Reported by Date (CDHPE)

On December 22, 2021, the one-week positivity rate in Weld County was 7.4% and the two-week positivity rate was 7.7%. Those numbers jumped to 11.2% (one-week positivity rate) and 9.4% (two-week positivity rate) as of December 30, 2022. The one-week and two-week positivity rates have skyrocketed to 30.6% and 30.4%, respectively, as of January 19, 2022.

Pursuant to the authority provided to Chief Judges by the Chief Justice of the Colorado Supreme Court through Chief Justice Directive 95-01, *Authority and Responsibility of Chief Judges*, I hereby order that all jury calls in the Nineteenth Judicial District be suspended through February 11, 2022. I will issue a separate order if the suspension on jury calls extends past February 14, 2022.

I will continue to closely monitor the COVID data for Weld County and I reserve the right to modify, revise, or extend Administrative Order 2022-01 at any time, based on then-existing data, health-related considerations, input from the members of the bench, and all other circumstances impacting court operations.
