II. Approval of Minutes

The September 15, 2023 minutes were approved as submitted.

III. Announcements from the Chair

Judge Harris made no announcements.

IV. Business

A. Gender Neutral Language in Rules

Judge Harris shared that the chairs of the various Colorado Supreme Court rules committees have formed a working group that is tasked with revising all of the Court's rules to be gender neutral. The working group has recommended following the Washington and Minnesota approach to eliminating gendered language. Once the supreme court has approved an approach, the various committees will be responsible for revising/editing the rules.

B. Legislative Subcommittee

i. SB23-254 (Abe Hutt, Judge VanGilder, and Christian Champagne) This subcommittee is dealing with bills that discuss warrants. The subcommittee believes that this legislation will require a rule change and will hopefully have a memo ahead of the next meeting.

ii. HB23-1151 (Judge Gerdes, Kevin McGreevy, and Johanna Coats)

The subcommittee presented some proposed amendments to Crim. P. 4.1, 4.2, 5, and 9 in response to HB23-1151. After a productive discussion, the subcommittee agreed to try to incorporate the members' feedback into further revisions and present an update to the full committee at the next meeting.

iii. HB23-1182 (Judge Nichols, Sheryl Berry, and Magdalena Rosa)

The subcommittee is unsure whether amendments to any rules would promote clarity or would only increase confusion. A Chief Justice Directive that covers this area may be updated soon, and the revisions may eliminate the need to amend the rules.

- iv. HB23-1187 (Matt Holman, Judge Vigil, and Karen Taylor)
 This subcommittee is in the early stages of considering whether any rule changes are necessary. At this point, the subcommittee believes it is possible that Crim. P. 35 may require changes as a response to the legislation.
- C. Changes to Crim. P. 37 and 37.1 Following Changes to C.A.R. 10 These revisions will be completed later.
