# **UPDATE: 18th Judicial District announces Lincoln County Court vacancy** *Commission sets date to select nominees*

The Eighteenth Judicial District Nominating Commission will meet on May 1, 2024, at the Arapahoe County Justice Center, 7325 S. Potomac, Centennial, CO 80112, to interview and select nominees for appointment by the governor to the office of county judge for Lincoln County. The vacancy will be created by the retirement of the Honorable Truston Lee Fisher. The vacancy will occur on June 1, 2024.

To be eligible, the applicant must be a qualified elector of Lincoln County at the time of investiture and have graduated high school or attained the equivalent of a high school education as indicated by the Department of Education, based upon the record made on the General Education Development test. The annual salary for this position is \$73,881.60, and it is a 40 percent position. The initial term of office of a county judge is a provisional term of two years; thereafter, the incumbent county judge, if approved by the voters, has a term of four years.

It is preferred that reference letters are included with your application submission. However, if they are submitted directly by the author, they must be submitted by email as described below in paragraph 3. All letters of reference are due by the filing deadline listed in paragraph 4.
