18th Judicial District announces additional Arapahoe County Court vacancy *Commission sets date to select nominees*

As previously announced, the Eighteenth Judicial District Nominating Commission will meet Aug. 26, 2016, at the Arapahoe County Justice Center to interview and select nominees for appointment by the governor to the office of county judge for Arapahoe County.

In addition to the vacancy created by the retirement of the Honorable Addison Adams, effective Jan. 10, 2017, another vacancy will be created by the retirement of the Honorable Alex R. Bencze, effective Jan. 1, 2017. All applications received by the Aug. 4, 2016, deadline will be considered for both vacancies.

To be eligible, the applicant must be a qualified elector of Arapahoe County at the time of investiture and must have been admitted to the practice of law in Colorado for five years. The current annual salary for this position is \$152,466. The initial term of office of a county judge is a provisional term of two years; thereafter, the incumbent county judge, if approved by the voters, has a term of four years.

The original, signed application and an identical copy stored as a PDF must be filed with the ex officio chair no later than 4 p.m. Aug. 4, 2016. Late applications will not be considered.

Any person wishing to suggest a candidate to fill the vacancy may do so by letter to be submitted to any member of the nominating commission, with a copy to the ex officio chair, no later than 4 p.m. July 28, 2016.

Instructions

1. The application form for a Colorado state court judgeship can be found on the Judicial Branch website at <http://www.courts.state.co.us/Careers/Judge.cfm>. You should only use the application that says it was updated 04/09. Do not use a prior version of the application. Please be complete and thorough in answering the questions; and, if an answer to any question requires more space than provided, attach a separate sheet of paper for each question.
2. Do not change the margins or font size on the application.
3. You must submit one original signed application along with an identical copy of your application electronically as a PDF file (preferably in text searchable format) on a CD or flash drive (these will not be returned). The electronic application does not need to contain a signature. If your application materials include multiple documents (i.e., cover letter, personal statement, reference letters) these documents should be combined into one single PDF document with the reference letters attached last.
4. You may submit **letters of reference from not less than three and no more than five** individuals who are in a position to comment upon your qualifications for a judicial position. You may include the reference letters with your application or have them sent directly to us at the address below. If sent directly by the author, they need only send us one original letter (in paper). If you include them with your application materials, please submit the original paper letter and also include it as part of your electronic application. It is your responsibility to ensure that all letters of reference are submitted to the by the filing deadline.
