Petition for Writ of Certiorari GRANTED as to the following issues:

Whether the court of appeals erred in finding that the trial court abused its discretion by denying the defendant's motion to continue the jury trial.

Whether the court of appeals erred in finding that the trial court violated the defendant's Sixth Amendment right to counsel.

Whether the court of appeals erred by not remanding the case to the trial court to allow the prosecution the opportunity to establish facts relevant to the requirements newly-imposed by Brown.

The judgment of the Colorado Court of Appeals is vacated, and the case is remanded to the Colorado Court of Appeals for reconsideration in light of People v. Brown, 11SC441, 2014 CO 25. EN BANC.
