| PETITION FOR UNDERAGE MARRIAGE | | |

The Petitioner, _____, hereby requests an order allowing him/her to enter into marriage while underage, and as grounds therefor, states as follows:

 - Has no parent or guardian;
 - The Petitioner's parent or guardian is not capable of consenting to the marriage;
 - The Petitioner's parent or guardian has not consented to the marriage.

OR

- The Petitioner is under the age of sixteen (16) and:
 - Has the consent of each parent capable of giving consent, **OR**
 - Has the consent of his or her guardian, **OR**
 - The Petitioner's parents are not living together and the Petitioner has the consent of his legal custodian or the parent with whom he/she is living with.

WHEREFORE, for the reasons set forth above, the Petitioner respectfully requests that the Court order the County Clerk and Recorder to issue a marriage license and marriage certificate form.
