 - b.) All documents regarding this appeal must be filed with the Clerk of County Court in the County where alleged E-470 violation occurred. Both the E-470 and County Court case numbers must appear on all documents filed with the Clerk of Court.
 - c.) All motions and correspondence shall include proof of service or a certificate of mailing as required by the Colorado Rules of Criminal Procedure.
 - d.) The original of all documents in this appeal must be filed with the Clerk of Court. It is the filing party's responsibility to deliver a copy of all documents filed with the Clerk of Court to E-470. Copies must be clearly marked "COPY".
