PETITION FOR RELIEF PURSUANT TO §13-5-142.5 OR §13-9-124 FROM FEDERAL FIREARMS PROHIBITIONS IMPOSED PURSUANT TO 18 U.S.C. §922(d)(4) and (g)(4)

OR
- The court has entered an order for my involuntary certification for short-term treatment of mental illness pursuant to §27-65-107, C.R.S. for extended certification for treatment of mental illness pursuant to §27-65-108, C.R.S., or for long-term care and treatment of mental illness pursuant to §27-65-109, C.R.S.
