**1. Background**

The Court has read the Defendant's Petition to Seal Multiple Conviction Records, examined the record, reviewed the current copy of the Defendant's criminal history record and, if applicable, considered any evidence presented at a hearing and any objections or responses filed in opposition to the Petition.

**2. Findings**

The Court hereby finds that it is appropriate to grant the Petition pursuant to C.R.S. § 24-72-709, as follows:

- The Defendant gave proper notice of the Petition to the prosecuting attorney's office.
- The offenses to be sealed are not among those listed in C.R.S. §§ 24-72-709(5)(a) or (c).
- The time requirements in C.R.S. § 24-72-709(2) have been met and according to the criminal history documents filed, the Defendant has not been convicted of a criminal offense in that period.
- The criminal history documents also reflect the Defendant is not disqualified for relief by C.R.S. § 24-72-709(3).

The offenses to be sealed include misdemeanors ineligible for sealing pursuant to C.R.S. § 24-72-709, but the Court finds that the harm to the privacy of the Defendant or the

dangers of unwarranted, adverse consequences to the Defendant outweigh the public interest in retaining the records.

**3. Decision**

The Court orders that the criminal records information specifically relating to and contained in:
