INSTRUCTIONS FOR FILING A CHANGE OF NAME FOR AN INDIVIDUAL 70 YEARS OF AGE OR OLDER

These standard instructions are for informational purposes only and do not constitute legal advice about your case. If you choose to represent yourself, you are bound by the same rules and procedures as an attorney.

GENERAL INFORMATION BEFORE YOU FILE YOUR PETITION

- These instructions only apply to a person who is at least 70 years of age, has not been convicted of a felony or adjudicated as a juvenile delinquent for an offense that would constitute a felony if committed by an adult in any state or under federal law, and is seeking a name change to harmonize name discrepancies necessary to be issued an identification card in Colorado.
- The Petition shall be filed in county court or district court in the county in which the person seeking a name change is a resident.
- The Court will not consider a Petition for a name change unless the following occurs:
 - ✓ A FBI and CBI fingerprint-based criminal history record check is conducted within 90 days prior to the filing of the Petition. If the fingerprint-based record checks were inconclusive because the fingerprints were unreadable or not discernable, a name-based criminal history record check conducted by the CBI shall be submitted to the Court.

- Detitioner: The person filing a Petition for Change of Name.

FEES

The filing fee is \$88.00 in county court or \$238.00 in district court. If you are unable to pay, you must complete the Motion to File without Payment and Supporting Financial Affidavit (JDF 205) and submit it to the Court. Once you submit the completed JDF 205 form and a blank Order (JDF 206), the Court will decide whether you need to pay the filing fee.

STEPS TO FILING YOUR CASE

Step 1: Complete required fingerprint-based criminal history checks.

The Petitioner must submit a criminal history check from the Colorado Bureau of Investigation (CBI) and Federal Bureau of Investigation (FBI) at the time the "Petition for Change of Name (70 Years of Age or Older)" is filed. Please follow these steps:

□ Law enforcement agencies are no longer required to provide fingerprinting for civil cases. Some law enforcement agencies will refer you to Colorado Application Background Services (CABS). Below is a link to the Colorado Bureau of Investigations website which includes information and instructions sorted by category:

Information for the FBI criminal history check can also be found on the CBI website.

- □ The criminal history results must be conducted within 90 days prior to the filing of the Petition.
- If you have a felony conviction recorded in Colorado or any other state, and you know that it is inaccurate, it is your responsibility to obtain the disposition information from the Court where such action occurred as identified in the CBI and FBI reports.
- □ You are also responsible for providing certified copies of any criminal dispositions that are not reflected in the Colorado Bureau of Investigations or Federal Bureau of Investigation records and any other dispositions which are unknown, by contacting the agency where such actions occurred.

Step 2: Complete appropriate forms.

Petition for Change of Name (70 Years of Age or Older) (JDF 389).

- Complete all sections of this form.
- □ Insert your full legal name and proposed name change as identified in the caption below.
 - □ Attach the fingerprint-based FBI criminal history record check to the Petition as Exhibit A and the fingerprint-based criminal history record check from the CBI as Exhibit B. If the fingerprint-based record checks were inconclusive because the fingerprints were unreadable or not discernable, a name-based criminal history record check conducted by the CBI shall be submitted to the Court along with the CBI/FBI notices indicating that a fingerprint-based check was not possible. Make sure that the fingerprint-based criminal history record checks are conducted within 90 days prior to the filing of the Petition.

 - Complete caption only.
 - □ The Judge or Magistrate will sign the Final Decree.

Step 3: File your Documents with the Court.

- Provide the Court with the documents completed as described in Steps 1 2 above and pay the filing fee.
- □ The Court may require a self-addressed stamped envelope.

Step 4: Obtain a signed copy of the Final Decree for Change of Name to Obtain Identity-Related Documents from the Court.

- □ You will need a certified copy of the Final Decree to provide to the Department of Revenue for it to issue a driver's license or identification card in your new name.
- □ The Court will provide you certified copies at no cost.
