**Colorado Supreme Court, Court of Appeals, Supreme Court Library and
Office of the State Court Administrator set to move**
Courts and library will open in new location Dec. 19, 2012

DENVER – The Colorado Supreme Court, Court of Appeals, Supreme Court Library and Office of the State Court Administrator will move from the Denver Newspaper Agency Building to the new Ralph L. Carr Colorado Judicial Center on Dec. 15 and 16, 2012.

The courts will close at noon Friday, Dec. 14, 2012, and will reopen in the Judicial Center (2 East 14th Avenue) at 8:00 a.m., Wednesday, Dec. 19, 2012. The library closed to the public on Friday, Nov. 23, 2012, and will reopen on Dec. 19, 2012. The Office of the State Court Administrator will close on Friday, Dec. 14, 2012, and will reopen in the Judicial Office Tower (1300 Broadway) on Monday, Dec. 17, 2012.

Any deadlines for filings in either the Supreme Court or Court of Appeals on Dec. 17 and 18, 2012, are automatically extended to Dec. 19, 2012.

The clerk's office at the courts' former location (101 W. Colfax Ave, Ste. 800, Denver, CO 80202) will remain open to accept emergency pleadings on Dec 17 and 18, 2012. The clerk's office will be open from 8:00 a.m. to 5:00 p.m. to accept emergency pleadings only.

The new address for the Supreme Court, Court of Appeals and Supreme Court Library will be 2 East 14th Avenue, Denver, CO 80203. The new phone number for the Supreme Court and

Court of Appeals clerk's office will be 720-625-5150. The phone number for the Supreme Court Library will be 720-625-5100. To contact any chambers in the Supreme Court or Court of Appeals dial 720-625-5000. The new address for the Office of the State Court Administrator will be 1300 Broadway, Ste. 1200, Denver, CO 80203. The new telephone number for the Office of the State Court Administrator will be 720-625-5000. All court and administration phone numbers will be changing and will be updated on the Judicial Branch Website (www.courts.state.co.us).

In anticipation of the move, the Supreme Court and Court of Appeals clerk's office will stop checking out records at 5 p.m. on Friday, Dec. 7, 2012, and will not accept records for return or filing until Friday, Dec. 21, 2012. Any records with a current due date during this period will receive an automatic extension of time until Dec. 21, 2012.

The Supreme Court will not be announcing any decisions on Dec. 17, 2012. The Court of Appeals will not be announcing any decisions on Dec. 20, 2012.

The Supreme Court courtroom will be located on the 4th floor of the Ralph L. Carr Judicial Center. Courtrooms for the Court of Appeals will be located on the 1st and 3rd floors. The library will be located on 1st floor of the Ralph L. Carr Judicial Center. Access to the Supreme Court, Court of Appeals and library will be through the main building lobby located on Lincoln and 14th Avenue. The Office of the State Court Administrator will occupy the 11th and 12th floors of the office building of the Ralph L. Carr Judicial Center and can be accessed by entering at 13th and Broadway.
