Colorado Supreme Court, Court of Appeals, Supreme Court Library moving *Courts and library will open in new location on April 19, 2010*

DENVER – The Colorado Supreme Court, Court of Appeals and Supreme Court Library will move out of their current locations in the state Judicial Building at 2 E. 14th Ave. later this month to allow for the beginning of work to replace the building with the Ralph L. Carr Colorado Judicial Complex.

The courts will close at noon Friday, April 16, 2010, and will reopen in the Denver Newspaper Agency Building at 101 W. Colfax Avenue at noon on Monday, April 19, 2010. The library will close to the public on Monday, April 5, 2010, and reopen in Denver Newspaper Agency Building on April 19.

The courtroom will be located on the ground floor of the Denver Newspaper Agency Building. Access to the courtroom will be through a separate, secured entrance off Broadway near Cheyenne Place. The library will be located on the ground floor of the Denver Newspaper Agency Building. Access to the library will be through the main building lobby. The clerks' offices will be located on the 8th floor. Access to the clerks' offices will be through the main building lobby.

All phone numbers will remain the same. The new address for the Supreme Court and Court of Appeals will be 101 W. Colfax Ave., Suite 800, Denver, CO 80202. The new address for the Supreme Court Library will be 101 W. Colfax Ave., Suite A, Denver, CO 80202.

In anticipation of the move, the Court of Appeals clerk's office will stop checking out records at 4 p.m. Monday, April 12, and will not accept records for return until Friday, April 23.
