<p><b>REASSIGNMENT OF EXISTING CASES SET FOR TRIAL</b></p>	

The following cases are being reassigned to facilitate the transition of Chief Judge Boyd's chambers to Garfield County and District Judge Nichols' chambers to Pitkin County. All cases with present settings shall remain set as is unless otherwise ordered. Some reassigned cases presently set in 2011 or 2012 need a review of the present setting to determine if the case can be heard as set; can be heard generally as set with an adjustment to one or more days within the trial; or must be rescheduled to a new date. For those cases below which require a review of the setting, Plaintiff's counsel shall be responsible for orchestrating the review in the manner and within the time frame stated below.


