Alonzo Payne, District Attorney for the Twelfth Judicial District, of the State of Colorado, in the name and by the authority of the People of the State of Colorado, informs the court of the following offenses committed, or triable, in the County of Alamosa:

COUNT 1-MURDER IN THE FIRST DEGREE (F1)

Between and including August 25, 2020 and August 27, 2020, Adre Baroz unlawfully, feloniously, after deliberation, and with the intent to cause the death of a person other than himself, caused the death of Korina Arroyo; in violation of section 18-3-102(1)(a), C.R.S.

COUNT 2-MURDER IN THE FIRST DEGREE (F1)

Between and including August 30, 2020 and September 4, 2020, Adre Baroz unlawfully, feloniously, after deliberation, and with the intent to cause the death of a person other than himself, caused the death of Selena Esquibel; in violation of section 18-3-102(1)(a), C.R.S.

COUNT 3-MURDER IN THE FIRST DEGREE (F1)

Between and including October 16, 2020 and October 17, 2020, Adre Baroz unlawfully, feloniously, after deliberation, and with the intent to cause the death of a person other than himself, caused the death of Xavier "Zeven" Garcia; in violation of section 18-3-102(1)(a), C.R.S.

COUNT 4-MURDER IN THE FIRST DEGREE (F1)

Between and including October 27, 2020 and October 31, 2020, Adre Baroz unlawfully, feloniously, after deliberation, and with the intent to cause the death of a person other than himself, caused the death of Myron Martinez; in violation of section 18-3-102(1)(a), C.R.S.

COUNT 5-MURDER IN THE FIRST DEGREE (F1)

Between and including October 29, 2020 and October 31, 2020, Adre Baroz unlawfully, feloniously, after deliberation, and with the intent to cause the death of a person other than himself, caused the death of Shayla Hammel; in violation of section 18-3-102(1)(a), C.R.S.

COUNT 6-TAMPERING WITH A DECEASED HUMAN BODY (F3)

Between and including August 25, 2020 and November 13, 2020, Adre Baroz, believing that an official proceeding was pending, in progress, or about to be instituted, and acting without legal right or authority, unlawfully and feloniously willfully destroyed, mutilated, concealed, removed, or altered a human body, part of a human body, or human remains of Selena Esquibel, with intent to impair its or their appearance or availability in the official proceedings; in violation of section 18-8-610.5, C.R.S.

COUNT 7-TAMPERING WITH A DECEASED HUMAN BODY (F3)

Between and including August 30, 2020 and November 13, 2020, Adre Baroz, believing that an official proceeding was pending, in progress, or about to be instituted, and acting without legal right or authority, unlawfully and feloniously willfully destroyed, mutilated, concealed, removed, or altered a human body, part of a human body, or human remains of Korina Arroyo, with intent to impair its or their appearance or availability in the official proceedings; in violation of section 18-8-610.5, C.R.S.

COUNT 8-TAMPERING WITH A DECEASED HUMAN BODY (F3)

Between and including October 16, 2020 and November 13, 2020, Adre Baroz, believing that an official proceeding was pending, in progress, or about to be instituted, and acting without legal right or authority, unlawfully and feloniously willfully destroyed, mutilated, concealed, removed, or altered a human body, part of a human body, or human remains of Xavier “Zeven” Garcia, with intent to impair its or their appearance or availability in the official proceedings; in violation of section 18-8-610.5, C.R.S.

COUNT 9-TAMPERING WITH A DECEASED HUMAN BODY (F3)

Between and including October 27, 2020 and November 13, 2020, Adre Baroz, believing that an official proceeding was pending, in progress, or about to be instituted, and acting without legal right or authority, unlawfully and feloniously willfully destroyed, mutilated, concealed, removed, or altered a human body, part of a human body, or human remains of Myron Martinez, with intent to impair its or their appearance or availability in the official proceedings; in violation of section 18-8-610.5, C.R.S.

COUNT 10-TAMPERING WITH A DECEASED HUMAN BODY (F3)

Between and including October 29, 2020 and November 10, 2020, Adre Baroz, believing that an official proceeding was pending, in progress, or about to be instituted, and acting without legal right or authority, unlawfully and feloniously willfully destroyed, mutilated, concealed, removed, or altered a human body, part of a human body, or human remains of Shayla Hammel, with intent to impair its or their appearance or availability in the official proceedings; in violation of section 18-8-610.5, C.R.S.

COUNT 11-ASSAULT IN THE FIRST DEGREE (F3)

Between and including August 25, 2020 and August 27, 2020, Adre Baroz, with intent to cause serious bodily injury to another person, unlawfully and feloniously caused serious bodily injury to Korina Arroyo, by means of a deadly weapon, namely: a bladed instrument; in violation of section 18-3-202(1)(a), C.R.S.

COUNT 12-SECOND DEGREE KIDNAPPING (F3)

Between and including August 30, 2020 and September 4, 2020, Adre Baroz unlawfully, feloniously, and knowingly seized and carried Selena Esquibel from one place to another without the consent of the victim and without lawful justification.

Further, the kidnapping was accomplished by the use of a deadly weapon, or any article used or fashioned in a manner to cause a person to reasonably believe that the article was a deadly weapon, or the defendant represented verbally or otherwise that he was armed with a deadly weapon, namely: Pistol; in violation of section 18-3-302(1),(4)(a)(II),(III), C.R.S.

COUNT 13-ASSAULT IN THE SECOND DEGREE (F4)

Between and including August 30, 2020 and September 4, 2020, Adre Baroz, with intent to cause bodily injury to another, unlawfully and feloniously caused bodily injury to Selena Esquibel, by means of a deadly weapon, namely: pistol; in violation of section 18-3-203(1)(b), C.R.S.

All offenses against the peace and dignity of the people of the State of Colorado.
