

**Correctional Treatment Fund Allocation to Adult Diversion Programs**

The Adult Diversion Funding Committee created these guidelines to assist diversion programs with accessing Correctional Treatment Funds. The Correctional Treatment Board has ultimate authority over use and reimbursement of funds, consistent with §18-19-103, C.R.S. **Requirements for the Use of Correctional Treatment Funds**

Submission of the Adult Diversion Funding Application by **April 5, 2022**, including a budget for Correctional Treatment Funds and anticipated expenses. See the Adult Diversion Funding Guidelines – FY23 for details.

Operation of an adult diversion program, pursuant to §18-1.3-101, C.R.S.

Compliance with Adult Diversion requirements, such as execution of an Interagency Agreement, reporting obligations, and submission of quarterly reimbursement requests. See the Adult Diversion Funding Guidelines – FY23 for details about reporting requirements and deadlines.

Satisfaction of other requirements established by the Correctional Treatment Board.

Submission of an Amended Funding Request if additional funds are needed. Amended Funding Requests are not required for adjustment of expenditures within or between Correctional Treatment budget categories.

**Permissible Uses of Correctional Treatment Funds, §18-19-103, C.R.S.**

**Alcohol and drug screening, assessment, and evaluation**

Alcohol and drug testing of adult diversion participants

Substance abuse education and training for adult diversion participants

Treatment for assessed substance abuse and/or co-occurring<sup>1</sup> (substance use and mental health disorders)

Recovery support services that remove barriers in attaining or maintaining sobriety or long-term recovery and support or reinforce mental health and/or substance abuse treatment. The Correctional Treatment Board has identified general categories and examples of services that may aid in recovery, set out below.

<b>Educational and/or Vocational Assistance</b>	Registration fee to attend a class to help obtain employment
	Boots, uniform, clothing, or tools for employment
<b>Emergency Housing and Food</b>	Food or grocery cards, housing vouchers or assistance, transitional and supportive housing, utilities, day care
<b>General Medical and/or Dental Assistance</b>	Physical health, dental, or optical care necessary to facilitate compliance, eyewear, and/or medications, including Medication Assisted Treatment
<b>Transportation Assistance</b>	Bus tickets or monthly discount passes, gas card, Uber/Lyft/etc.
<b>Special Needs Services</b>	Standalone treatment (e.g., anger management, parenting skills, social support/mentoring, art, or other therapies)
	Payment of fees
	Restorative services such as mediation, impact panels, etc.
	Recreation center passes
	Supplies for therapy or classes (books, etc.)
	Sobriety coach

The Adult Diversion Funding Committee may adjust Correctional Treatment Fund allocations after the third quarter of the fiscal year, based on fund utilization and need.

<sup>1</sup> Correctional Treatment Funds cannot be used for mental health treatment needs absent a co-occurring substance use disorder.
