These attorneys will consider a person's financial situation when they assess legal fees for a particular service case. This list is updated on a quarterly basis. The purpose of this Directory is to provide attorney names to potential clients who have low or moderate means or who have chosen to self-represent, yet are in need of limited legal counsel.
