We assist anyone, who is not already represented by an attorney, and is seeking information about how to file, pursue, or respond to a civil (non-criminal) matter or case.

What does Self-Help do?

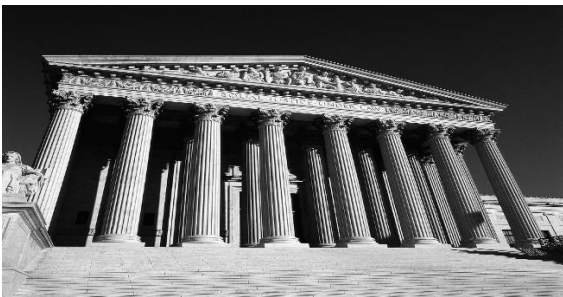
As a Court employee, the Program Coordinator helps the public with general questions, information, resources, forms, and instructions related to most civil matters, whether a case already exists or not. We also educate individuals on state statutes, rules, policies and procedures that may be applicable.

How much does it cost?

This is a **FREE** service provided by the Court to everyone without regard to financial resources.



Why access Self Help?

- ✓ For information on state statutes, rules, policies, and procedures;
- ✓ For help determining which forms to complete & for assistance with completing them;
- ✓ For guidance to the process of scheduling hearings and mediation, status checks, court limitations and general follow-up;
- ✓ For education & assistance in case processing & courtroom procedures and policies;
- ✓ For support with instructional packets;
- ✓ For resource & referral to other community services, including other legal resources.

Self Help does NOT:

- ✓ Recommend whether to file a case.
- ✓ Speculate on a case strength or outcome;
- ✓ Represent parties to a case.
- ✓ Provide legal advice, analysis, or strategy.
- ✓ Offer support in criminal, administrative or federal legal matters or cases.

How do I access Self Help?

How do I make an appointment?

We offer appointments in-person or by phone by contacting your local court of choice in-person or by phone.

If your appointment is by phone, you are responsible for contacting the court on time. In addition, access to a computer and internet is helpful, though not required.

- ✓ Divorce, child support, child custody, adoption, paternity
- ✓ Civil Restraining/Protection order
- ✓ Tenant-Landlord disputes, Eviction
- ✓ Small claims
- ✓ County & district court civil cases
- ✓ Employment disputes
- ✓ Probate, guardianship, conservatorship
- ✓ Post-judgment collection alternatives
- ✓ Name Change
- ✓ Water rights
- ✓ Other civil matters.
