Updated Redwine Jury Trial Procedure for the Trial Scheduled June 14, 2021 (C-63)	

Due to the current state of new COVID-19 infections, vaccination rates, and COVID-19 test positivity rates in La Plata County, and considering all applicable executive and public health orders, the Court is again changing the procedures that will be used during Mr. Redwine's trial scheduled to begin on June 14, 2021.

- a. The provisions of Administrative Order 2021-12 shall apply and shall control the wearing of facial coverings and social distancing in the courtroom. The well and public seating area of the courtroom will be marked to designate seating for members of the venire, members of the public, and for the jury with appropriate social distancing.
- b. The entire trial, with the exceptions stated below, will be streamed on the Internet via Webex Events. Counsel, the defendant, and members of each litigation team should remember that the microphones in the courtroom will be on throughout the entire trial and, unless microphones are muted, conversations at counsel table, the lectern, or near other microphones are likely to be heard by anyone streaming the trial.
- c. Starting Monday, June 14th, through Tuesday, June 22nd, the jury commissioner will call three waves of venire large enough for 33 jurors in each wave. The jurors will be called at 8:00AM, 11:00AM, and 2:30 PM. For each wave, the bailiff will seat each member of the venire in an assigned seat and make a list showing the seat number in which each member of the venire is seated. The list made by the bailiff will be made part of the record. The Court will conduct its voir dire as to each wave and, upon completing its voir dire, give the remaining members of the venire the questionnaire. Upon completing the questionnaire, each member of the venire shall be excused. Once excused, each member of the remaining venire shall be told when to return for individual voir dire and shall

provide the bailiff with contact information. The jury selection proceedings shall be broadcast via Webex (audio only) and, except for individual voir dire, will be available for the public to observe. If by Wednesday, June 16th, 65 or more members of the venire remain, the Court shall begin individual voir dire on Thursday, June 17th. If insufficient members of the venire remain as of June 16th, the Court shall continue its voir dire of the venire until a sufficient number of the venire remain to begin individual voir dire.

- d. Individual voir dire shall be held in Division 4 with the bailiffs to stage jurors outside of the courtroom until each is needed. Due to the personal nature and purpose of individual voir dire, individual voir dire shall be closed to the public and shall not be broadcast via Webex. Individual voir dire shall be limited to five minutes per juror per side, with the individual questioning being limited to the juror's responses, or lack of responses, on their questionnaire.

- e. After individual voir dire, the bailiff shall randomly assign numbers to the jurors who remain. Jurors assigned numbers 1-44 shall be called for the general voir dire by the attorneys starting at 8:00 AM on Monday, June 21st, and sit in the seat number which corresponds to the number previously assigned to them by the bailiff. The remaining jurors shall report to the courthouse at 1:00 PM on Monday, June 21st. Counsel voir dire shall be limited to a 75-minute voir dire as to the first 36 members of the venire located in Division 4. If less than 28 jurors remain after the parties' challenges for cause, the parties shall be allowed to conduct general voir dire of the remaining 8 members of the venire that are in the courtroom. If 28 or more jurors remain after the parties have exercised their challenges for cause, the parties shall exercise their preemptory challenges. If less than 28 members of the venire remain after the parties have completed their general voir dire, the jury panel will be dismissed until a time set by the Court and the parties' general voir dire will continue with the 1:00 PM panel. The new panel will sit in the order of the numbers previously assigned to them by the bailiff. Depending upon the number of jurors needed, the Court may place appropriate time limits on counsel for voir dire with this second panel.
- f. Counsel should be prepared for opening statements and the presentation of evidence to begin on the afternoon of Monday, June 21, 2021. Opening statements shall be limited to one hour for each side.
- g. Once the presentation of evidence begins, the Court intends to recess for the weekend by noon or early afternoon each Friday.
- h. Bench conferences shall be allowed. However, only one attorney from each side may participate in bench conferences.
- i. All exhibits will be marked with an exhibit number and the case number prior to the presentation of evidence. Both sides shall provide the Court with an exhibit book containing pre-marked proposed exhibits prior to the presentation of evidence. The defense exhibit book will remain confidential and not shared with the prosecution. Exhibits to be shown to the jury will, to the extent possible, be displayed electronically as they are introduced. Counsel shall ensure that they are able to connect to the court's video screen prior to the beginning of the presentation of evidence. Hard copies of the exhibits shall be given to the Court

to allow the bailiff to place them in the juror notebooks during recesses. All juror notebook copies of exhibits will be three-hole punched.
