

DISCOUNTED FEE ATTORNEY LIST, 2013
(Updated June, 2013)

The 1st Judicial District (JD) Access to Justice Committee with the 1st JD Bar Association has compiled a list of attorneys willing to offer discounted fees for legal services. A person's financial situation will be considered when legal fees are assessed for a particular service case. The list is updated in January and June each year.

The list will be distributed to 1st JD Courts, (Jefferson and Gilpin Counties) and to other venues that assist citizens of the 1st JD Jefferson County. This list is intended to help parties in conflict, who do not qualify for legal aid, but who still are in need of financial assistance in obtaining legal services.

Please be aware that these attorneys are not required to accept any case that comes to them by way of this list – only that they have made their services available at a discounted fee, should they choose to accept a case after speaking with a party.

Neither the Access to Justice Committee, nor the 1st JD Bar Association endorses any attorney on this list, nor does either entity make any representation as to the quality of work performed by any of them. Each attorney has represented that he/she is a licensed attorney in good standing with the Colorado Supreme Court.
