THE COURT ORDERS THAT:

The Colorado Mental Health Institute at Pueblo is to provide copies of the following documentation related to the Defendant's commitment for competency and restoration to competency:

any and all records of Robert Lewis Dear, Jr., (DOB 4/16/58) from May 20, 2016 to present that is generated by, reviewed by, relied on, or created by the staff, employees and/or doctors in relation to the Defendant's competency or restoration to competency. Such documents may include, by way of example, any and all reports, whether in a formal report format or not, completed by the evaluators or treatment team; any and all reports whether in a formal report format or not, completed by experts or professionals provided to the evaluators and/or treatment team at the Colorado Mental Health Institute at Pueblo that has been reviewed by or relied on by the evaluators and/or treatment team; observation logs; notes; medication logs; food logs; working filed; testing results (include raw data); security reports; grievance forms; or other documentation that is associated with Defendant and his competency and restoration to competency and in relations to his diagnosis of delusional disorder.

The Court also orders the Colorado Mental Health Institute at Pueblo **REDACT** the records for any personal medical information that is deemed unrelated to the Defendant's competency and/or restoration to competency, or unrelated to his diagnosis of delusional disorder. If the Colorado Mental Health Institute at Pueblo is unsure if information on a document should be redacted or not the Colorado Mental Health Institute at Pueblo shall provide those documents to the Court with a request for an in camera review to be conducted by the Court.

The Court orders the Colorado Mental Health Institute at Pueblo to provide any and all audio and/or video files reviewed, relied on, and/or created by staff, evaluators, and/or the treatment team. This does not include copies of audio and/or video files that were provided to the Colorado Mental Health Institute at Pueblo by the prosecution as such audio and/or video files have already been provided to the Defendant through the discovery process and continued duplications of those items is unnecessary.
