2 MR. OLTMANN: How you guys doing? All right.  
3 So I'm going to do another video on "Conservative  
4 Daily," too, but you're going to want to see this,  
5 you're going to want to share this. I -- I don't even  
6 know how to -- I don't even know how to tell you how  
7 upset I am right now. I'm upset, but I'm upset and  
8 vindicated all at the same time, so please hit the  
9 share button. I'd like to get as many people as  
10 possible. Even if you hit this before, I want you to  
11 hit the share button because you're not going to  
12 believe what I'm about to tell you. Actually -- you  
13 know -- I've been holding onto some of it and then I  
14 said to myself -- you know what -- why hold onto it?  
15 Why not just tell everyone what the hell is going on  
16 when it relates to Coomer and all of the rest of the  
17 things that he's doing? So I'm going to start this by  
18 saying this. If you're a doubter and you said, "Oh --  
19 you know -- there's no way that Joe could have been on  
20 that call" -- and I keep saying it's providential. I  
21 keep telling you that I did my research. Any of --  
22 any of you that know me know that I would never -- I  
23 would never step out and say this person was on that  
24 call, this person did that unless I was 100 percent  
25 sure and those of you that have had me help you --

1 right -- because you got in trouble or -- you know --  
2 you had a brother got in trouble or your sister got in  
3 trouble, you know who I am. You know who -- you know

5 today I came back from hanging out with my family and  
6 someone from California who keeps tabs and gives me  
7 research hit me up and -- and sent me a message and  
8 she goes, "Did you see this article from "The Gateway  
9 Pundit?" And so "The Gateway Pundit" article was  
10 about a woman named Jennifer Morrell and Jennifer  
11 Morrell works for a Soros-backed nonprofit -- a Soros-  
12 backed nonprofit that is now suspected -- well,  
13 definitely shady, if not criminal, activity in  
14 multiple states. She works for a thing called The  
15 Election Project and before that she worked for some

3 at his house with the -- with the county clerks in  
4 August of 2018 -- August 22 to be exact -- with  
5 representatives from the Secretary of State's office,  
6 with Matt Crane -- I'll use Matt Crane because -- you  
7 know -- he's good friends with Eric Coomer -- and  
8 they're just hanging out buddy-buddy. Now you fast  
9 forward and you see what's just happened with the  
10 election and now under massive scrutiny for fraud and  
11 here we are. Here we are with the woman that is  
12 subject to -- and -- and by the way, I wasn't doing  
13 any research on her either, it was providential. I  
14 saw the article the same time that some other people  
15 did. It launched today. But hanging out and having a  
16 barbeque at Eric Coomer's house with the county clerk  
17 and recorders. It's pretty interesting, isn't it?  
18 And she's the one in multiple states that is being  
19 accused of some pretty bad behavior, if not criminal  
20 behavior, across the country. Now here's something  
21 else you should know. I want to give you an update on  
22 the Coomer lawsuit -- you know -- the -- the one where  
23 he said that he's suing me for defamation. In a place  
24 where there is no proper venue -- in other words, no  
25 one is in the city and county of Denver. No one -- no

1 one is in the city and county of Denver, but they  
2 filed it in the city and county of Denver because it's  
3 really, really blue and they have control over the  
4 judges and they have control over the judicial system,  
5 which is completely compromised and completely  
6 corrupt. So that's number one. So then we had a  
7 judge -- and I want to give this to you because this  
8 is going to be -- this is going to be really important  
9 that you understand this -- and when I tell you that  
10 we -- we're past the place where we can just have a  
11 discussion about it -- where we can compromise --  
12 we're past that point. We have evil that has  
13 penetrated every part of our country. But we had a  
14 judge on the case and that judge was moved and then we  
15 had another judge called Judge Rappaport. Judge  
16 Rappaport, in her 20-year history on the bench had had  
17 her cases overturned three times. Then we have this  
18 new judge that came in that was appointed to the bench  
19 by none other than Jared Polis, the Governor of  
20 Colorado, on March 23 -- on March 23 and she was  
21 brought in and put on the bench in May. Now there's a  
22 presiding judge that has to assign cases, so a  
23 presiding judge in the city and county of Denver  
24 handed Maria (ph) or Marie Avery Moses -- handed her a  
25 case -- our case -- the Coomer case. Now just before

1 she got on the bench -- four days before -- there was  
2 a -- there was a ruling by Rappaport and a very well  
3 written out ruling that says you don't get access to  
4 discovery. It had legal basis behind that -- the  
5 legal basis behind that. Now fast forward four days  
6 later, we had a status conference. She had been on  
7 the bench now for less than two weeks. Less than two  
8 weeks she had been on the bench and she did what is a  
9 called a sua sponte. A sua sponte is basically giving  
10 the plaintiff the ability -- because the law of the  
11 case -- just so you know -- the law of the case is  
12 pronounced by the previous judge, so when you come in,  
13 you respect the law of the case, but not Moses -- not  
14 this person, Moses, that was assigned by Polis. See,  
15 she's an activist, she's not a judge. She's an  
16 activist who stands against the rule of law -- stands  
17 against truth. So she comes in and files -- or says  
18 in a sua sponte -- sua sponte means she volunteers it.  
19 She goes to the plaintiff and she goes, "I'm going to  
20 give you an opportunity -- I'm going to give you an  
21 opportunity to -- to overturn" -- or excuse me -- "to  
22 file a motion to overturn Judge Rappaport's ruling  
23 that you don't get access to discovery." They had  
24 four days to do that. Promptly, four days later  
25 before the ink is even dry by the -- Coomer's

1 attorneys, she overrules a 20-year judge after being  
2 on the bench for less than a couple of weeks. That's  
3 our judicial system right there, but I'm not done yet.  
4 See, you're going to want to share this -- you're  
5 going to want to share every part of this because  
6 you're going to know how corrupt these people are. So  
7 then we want to go to the -- the next part of this  
8 equation and that is she found that there was a  
9 probable falsity and wanted me to give up the name to  
10 the Antifa member that gave me access to that phone

13 threaten him, send powder to his house, destroy his  
14 family, make sure he can never have another job? You  
15 -- I should give up his name. I will never give up  
16 his name. Now I just told you about Jennifer Morrell,  
17 who happens to be one of the people that is connected  
18 to Eric Coomer who had a party at his house in August  
19 of 2019, who -- by the way -- Eric Coomer is the same  
20 person that posted the Antifa Manifesto and as they  
21 say -- sarcasm -- in saying they would wish people  
22 dead, including police officers -- death to America  
23 and anti-Trump rhetoric. This is where it gets  
24 interesting. So I started doing research on the  
25 judge. In June of 2020, that same person that got put



1 on the bench by Jared Polis marched in the Antifa BLM  
2 protest. June of 2020 -- I've got screenshots -- I've  
3 got screenshots. So we've been going through this  
4 entire process and -- oh, the left-leaning part and --  
5 and -- and people that are in her circle posting up  
6 saying, "Kamala Harrison (ph) and Avery Moses, they  
7 have the same birthday. I'm so happy with those  
8 people." This is what we get. This is what we get.  
9 Let me know if you guys can hear me. Please let me  
10 know if you can hear me. They don't want this video  
11 to get out. I know that Facebook is standing on the  
12 middle of this video. The judge should -- should  
13 recuse herself. The case should be thrown out. We  
14 are not dealing with a small amount of fraud. We're  
15 dealing with massive fraud at a massive scale and do  
16 you think that I care that I'm under attack? I don't  
17 care that I'm under attack -- I don't care. What I do  
18 care about is that we don't have this unethical,  
19 imbalanced basis of persecution against people. It's  
20 not just me, it's the people that are sitting in jail  
21 from January 6 on this -- this clown fest they have  
22 that are being abused inside the jails. Our country  
23 is lost and I'm -- I'm done sitting here saying and  
24 look in -- I got to walk in and treat a judge with  
25 respect. She's not a judge, she's an activist. She

1 proved she was an activist. She never should have  
2 been on this case. She never should have done a sua  
3 sponte ruling and given them another bit of the apple,  
4 but we're dealing out massive corruption in our  
5 country. People want to say I'm pissed off. You're -  
6 - you're fucking right, I'm pissed off -- I'm pissed  
7 off and you want to know why I'm pissed off is because  
8 these shitbags -- we don't stand up enough against  
9 them. I'm -- I'm past pissed. So I'm just telling  
10 you, please share it -- please share it. I'm going to  
11 put it up everywhere. I've called every news outlet  
12 and every person that I know that knows about all  
13 these connections. I've sent up the pictures. I've  
14 done everything that I have to do. The judge walks  
15 away and they change the venue back to a place -- we  
16 can go to Salida and go up there -- we can go to that  
17 district. We can go to Douglas County -- I'm in  
18 Douglas County -- we can go there, but you're not  
19 going to go shop it around and put it wherever you  
20 want. And the -- and to you -- because I know you're  
21 listening -- the lawyer for Coomer -- you're a piece  
22 of trash. You stand up for trash -- you are trash.  
23 So you went after my family -- you've -- you've done  
24 everything to disrupt my life. We're going to have a  
25 countersuit. We are going to get this to federal

1 court and we're going to do everything we can to crush  
2 you and if you think I -- for -- till my dying day --  
3 till my last breath, I will make sure I go after every  
4 single one of you that stole this election, that stole  
5 our country, stole our voice. And if you think I give  
6 a shit about how much money I make -- you think I care  
7 about any of that? I don't care about any of it.  
8 What I care about is that we have a country founded on  
9 principles and founded on the Constitution and, by  
10 God, if I grow up a poor man as a result of that, I  
11 will definitely do it. Hey, listen, God bless you. I  
12 -- I think I'm done talking right now. I'm about to  
13 have a heart attack, but I figured you'd want to know  
14 -- I figured you want to know. I'll put the link to  
15 "The Gateway Pundit" article below. I'll also post  
16 the pictures, so you can see what I am saying is  
17 absolutely true. Listen, I -- I'm going to need some  
18 help at some point. I've never asked for help -- I  
19 mean -- I did kind of, but -- you know -- this -- this  
20 fight is getting pretty -- pretty messy and -- but I  
21 want you to see it. I want you to see every part of  
22 it. I want you to see what we're really dealing with.  
23 We're dealing with frauds -- these people are frauds -  
24 - they're frauds. They're complete evil leftist  
25 shitbags and if you're a liberal -- look, I'm not
