TIPS TO PREPARE FOR YOUR HEARING

- Test these instructions at least a week before your hearing, so you have time to get tech assistance if needed.
- Test your connection 15 minutes before your hearing starts
- Have your computer or cell phone charged and video turned on

- Virtual court still has all the expectations of in-person court
- Have a quiet, private space without distractions available
- Dress as if you were making a court appearance in person

- Have your notes on what you would like to say prepared
- Have pen and paper ready to take notes
