The return filing of charges in 15CR5795 (People of the State of Colorado v. Robert Dear) is set for Wednesday, Dec. 9, 2015, at 1:30 p.m. in Courtroom W570 (Division 10) of the El Paso County Judicial Building (270 S. Tejon Street, Colorado Springs, CO 80901). Chief Judge Gilbert Martinez will preside.

**SEATING:**

The following media outlets will each have one seat in Courtroom W570. Media registration for courtroom credentials will be held Wednesday from 12:45 to 1:15 p.m. outside Courtroom W570. In the event credentials are not picked up for one or more of the media outlets listed below, those seats will be given away on a first-come, first-served basis at 1:15 p.m. Wednesday. You will need a valid media credential to pick up your credential for the courtroom.

**EXPANDED MEDIA COVERAGE (EMC):**

The Denver Post and KUSA have filed EMC requests with the Court for stills and audio/video. A ruling is pending. Once the Court has ruled it will be posted to the case filings page referenced below. If EMC is granted, I will reach out to The Denver Post and KUSA to coordinate the photographers' access to the courtroom.

**SKETCH ARTIST:**

The Court will allow a sketch artist in the courtroom if the media so desires. The sketch artist will need to occupy one of the 25 seats allotted to the media. Thus, one media outlet must be willing to give up their seat to accommodate the sketch artist.

**DECORUM ORDER AND CASE FILINGS:**

The Court has issued a decorum order. Please make sure you have reviewed the decorum order prior to arriving at the courthouse Wednesday.
