Your Affiant, Detective Marissa Williams / 12009, hereafter referred to as "I", a Deputy Sheriff for the El Paso County Sheriff's Office, currently assigned to the Investigations Division, state under oath that I have personal knowledge of the following facts:

The facts set forth within this affidavit are based upon information Your Affiant has gained from this investigation, Your Affiant's personal observations, Your Affiant's training and experience, and/or information related to Your Affiant by other law enforcement officers. Since this affidavit is being submitted for the limited purpose of securing a search warrant, Your Affiant has not included each and every fact known to him concerning this investigation, but has set forth only the facts that are necessary to establish probable cause to believe that a crime has occurred.

All information contained in this affidavit can be found documented under El Paso County Sheriff's Office case report #20-1382.

On Monday January 27, 2020 at approximately 1855 hours, El Paso County Sheriff's Deputy Sean Donahoue responded to the address of 6627 Mandan Drive, in El Paso County, Colorado, which is a single-family residence. Letecia Stauch (DOB 08/04/83) called into the Sheriff's Office to report her stepson Gannon Stauch (DOB 09/29/08) missing. She stated he left the residence on foot at approximately 1515 hours and was expected to return around 1800 hours. When he did not return, she checked a friend's house. She stated his friend had not seen Gannon. Letecia called law enforcement to report Gannon missing.

During the subsequent 40-hour period, Letecia refused to meet with the Sheriff's Office or provide requested information or materials relating to her missing step-son. During this period of time, she had limited communication with Detective Jessica Bethel and her husband, Eugene Albert Stauch. Mr.

Stauch was cooperative and came in for an interview and provided all requested material relating to himself, his wife, and his son. He advised that he and his wife had three vehicles total in their names: a 2019 Volkswagen Tiguan (which she normally drives), a 2016 Nissan Frontier (which he normally drives), and a Volkswagen Jetta (which Letecia's daughter Harley normally drives). However, Letecia rented a 2019 Kia Rio, because she stated she was concerned about putting mileage on the Tiguan, and would not tell anyone where the Tiguan was. Letecia also made the following conflicting statements:

She initially told the deputy who took the missing person case she drove her Tiguan on Monday, but changed her statement and said she had not.

She told responding deputies her 8-year-old daughter Laina had seen Gannon on Monday around 1515 hours. However, Laina said the last time she saw her brother was Sunday night.

She told Detective Bethel she left the house between 1030 and 1430 hours on Monday, but only went to PetCo to buy dog clothes. (Two receipts for PetCo were found in the Nissan Fronter, for Monday January 27, one for 1122 hours and one for 1322 hours, both for dog clothes). She claimed Gannon stayed home from school Monday because he was having stomach problems (diarrhea), and that he has incontinence issues. However, she stated he stayed in the truck the entire time and did not come into any of the stores. Video surveillance at PetCo and nearby stores show Letecia park the Nissan Frontier at approximately 1115 hours in the parking lot in front of PetCo. She enters the store and buys dog clothes and leaves the store, gets in her vehicle, and leaves the parking lot at approximately 1125 hours. Again, the Nissan Frontier returns to the parking lot around 1315 hours. Letecia enters PetCo and purchases dog clothes, leaves the store, gets into her truck and then pulls out of the parking lot at approximately 1325 hours. The time between these two purchases is unaccounted for, as well as the time between which she leaves her residence and arrives at the store (approximately 21 miles away).

She is an employee of Widefield School District 3. Per the school district, she called in sick on Monday January 27th. She also called in sick on the 28th and provided the reason that her father-in-law had been killed.

She sent a photograph of Gannon's bedroom in order with clothes folded on the bed at approximately 1700 hours on Monday. However, when deputies arrived at the residence Monday night after Letecia called, Gannon's room was disorderly.

She has been communicating with her 17-year-old daughter Harley via text message and Facebook application continuously. Harley, however, has refused to talk to law enforcement regarding any knowledge of her step-brother Gannon's whereabouts.

On Wednesday January 29, 2020 at approximately 1200 hours Letecia drove to the El Paso County Sheriff's Office at 27 E Vermijo Ave (in El Paso County), and met with detectives. Detective Kat Huston interviewed Letecia, during which time she changed her statement regarding her step-son's disappearance.

Letecia told Detective Huston she had been raped by a stranger and her step-son was abducted by the same man. She said this happened Monday afternoon. The night before, Gannon had accidentally burned part of the carpet inside the house and they cut a square of damaged carpet out. Letecia said she left the house and drove somewhere in the neighborhood, to a construction area, until she found a man who was working on a house. She identified the man as "Edguardo." She asked the man to come to her house to repair the carpet. She said she gave him the garage code and he agreed to come to her house and replace the carpet while she went shopping. She said he brought a roll of carpet with him.

Letecia said she left the house and went shopping and came home at approximately 1430 hours. When she walked in the house, she disarmed her security system and went downstairs at which point the man pointed a handgun at her. He allowed her to go upstairs to greet her younger step-daughter, 8-year-old Laina, who she sent outside to go ride her bike. Letecia said she went downstairs again and the man forced her onto Gannon's bed inside his bedroom in the basement. There, the man penetrated her vaginally with his penis and sexually assaulted her between 1530 and 1630 hours. Letecia said she tried to fight her attacker off her but was unsuccessful. During the attack, the Letecia stated her head struck a table. Once the attacker had finished, he took Gannon and left the house. Gannon has not been found.

Letecia also stated Gannon was bleeding during the attack, because he jumped on the attacker at one point. She also claimed the bleeding was caused by him having burned himself when he accidentally burned the carpet. She also previously stated he had cut himself on the candle he knocked over, but the candle was found intact in the trash can. She also stated she threw away a bloody, torn shirt belonging to Gannon. That shirt was not found.

When Letecia came to the Sheriff's Office, she arrived in the missing Volkswagen Tiguan. The vehicle was wet from just having been washed, as the weather was dry. As the vehicle dried, it was clear that there was damage to the sidewalls of all four of the vehicle's tires, as well as the lower part of the body and the fenders. The top of the vehicle was also still heavily coated in dirt.

A search of the residence at 6627 Mandan Dr was completed again on Wednesday January 29 with the Colorado Springs Metro Crime Laboratory's assistance. A roll of carpet was found inside the house in a storage area. Inside the carpet (which did match the carpet installed in the house) there was carpet that did not match, stained with blood. There was also a square of carpet matching the size of the carpet that had been cut out.

When Letecia came to the Sheriff's Office, she brought with her a rose gold Apple iPhone 8 in a teal case and a black Marc New York purse. Inside that black purse she had a wallet containing her identification and several financial cards. She also had a sheet of paper on which she had written notes she intended to read to detectives during her interview. She never read those notes.

Throughout the time between which Letecia initially made the report of Gannon having gone missing and the time that she arrived at the Sheriff's Office, she has been in communication with her husband, as well as other family members, about Gannon's disappearance. She has also made several social media posts about the incident. It is common for persons with smartphones to access social media websites via app on their cell phones.

Letecia's cell phone is also linked to the Ring doorbell security camera on the front of her residence via app. Mr. Stauch stated Letecia is the only one with access to the Ring doorbell camera system for their house.

At 0300 hours Monday morning, Letecia also called into work (Academy School District 20), by texting her supervisor that her father-in-law had been killed.

Mr. Stauch provided all of the financial account information he knew about regarding himself and his wife. The PetCo receipts show Letecia purchased the dog clothes using an American Express card, but Mr. Stauch was unaware of her having an American Express card and did not know if she had other credit cards. During her interview on Wednesday, Letecia stated she used her credit card to make other purchases while she was out shopping on Monday and said Gannon was with her, but he remained in the car the whole time. She could not provide specific information on where she went Monday besides PetCo.

In furtherance of this case Your Affiant submits that it is necessary and reasonable to search the phone and the purse belonging to Letecia in order to ascertain past location and communication, as it will aid in the location of the missing child Gannon. Additionally, identification of any handwritten notes and any financial accounts potentially used will aid in identifying information Letecia did not provide to law enforcement about events that did or did not occur, as well as financial accounts she has access to, which may have been used during time Letecia has not accounted for between Sunday night and Wednesday afternoon.

Based on the Colorado Revised Statutes 18-8-111, False Reporting to Authorities, if a person knowingly makes a report to law enforcement of a crime or incident within law enforcements official concern (such as a runaway child, a kidnapping, or a sexual assault) he or she knows did not occur, he or she commits such offense. Based on the facts and circumstances described here, Letecia made a false report to law enforcement regarding Gannon running away from the residence at 1500 hours on Monday, because on Wednesday around 1200 hours, Letecia changed her statement and told law enforcement he had been abducted by an unknown person who sexually assaulted her.


