Comes now, Michael J. Allen, District Attorney for the Fourth Judicial District, and his duly appointed Chief Deputies, respectfully submits the following, [D-7] People's Response to Defendant's Demand for A Preliminary Hearing. In support thereof, the People state:

1. The Colorado Rules of Criminal Procedure govern the demand for a preliminary hearing – obviously given the magnitude of the injury and harm inflicted in the instant case, the People anticipate filing triggering offenses sufficient that not only a preliminary hearing but a proof evident hearing will be necessitated. However, to the extent that a complaint and information hasn't been tendered in this case, such a request is premature and to extent communication with the client could not possibly have occurred in respect even as to the nature of the charges, the People object to formal demand occurring prior to this event.

2. In their motion, the Defendant makes reference to the Defendant's Constitutional right to a bond – the People would note the obvious statutory guidance for the Court's consideration of when a Defendant may be held without bond, in the aforementioned proof evident hearing and would ask the Court to defer any determination of bond until such time.

Wherefore, the People respectfully request this Court to defer ruling on the Defendant's Motion until such time as a complaint and information is filed, and a future hearing date is determined.
