NARRATIVE

Investigator Martinez Supplemental Report #24

Friday, July 21, 2023

I, Investigator Kimberly Martinez of the 4th Judicial District Attorney's Office, was advised that Howard Black, Director of Communications for the 4th Judicial District Attorney's Office, had attempted to contact "*ThisNow News*", via email, requesting they call our office, referencing the release of court records that were in violation of the courts direct order, referenced in *Defense Motion 31 "Notice of Violation of Court's Order*", in criminal case 2022CR6008-21, defendant **Anderson Aldrich DOB: 05/20/2000**.

The email was sent to website@nowthismedia.com which can be located on https://nowthisnews.com by scrolling to the bottom of the main page and clicking "Contact Us". This email was sent on Thursday, July 6, 2023, at about 9:23am. As of Friday, July 21, 2023, Mr. Black had not received a response.

On the website of https://nowthisnews.com, at the bottom of the main page, it states "VOXMEDIA" and "This publication is a Vox Media network", which shows a copywrite in 2023 by Vox Media, LLC.

I attempted to locate additional contact information by searching Vox Media and was able to locate three phone numbers and two potential emails associated to the company.

At about 3:33pm, I called phone number 202-591-1140, which did not ring and went to a voicemail that was full. I then called the number again to verify I dialed the correct number and received the same response.

At about 3:37pm, I called phone number 202-747-1290, which was not a working phone number.

At about 3:37pm, I called phone number 1-800-478-9140, which was not a working phone number.

At about 3:49pm, I sent an email to Geoff.Schiller@voxmedia.com and Samantha.Mason@voxmedia.com. In the email, I advised them that my office had attempted to reach out on July 6, 2023, to an email of website@nowthismedia.com with no success, and advised them of the purpose of our attempted contact.

At about 4:01pm, I received a response from "Samantha Mason" and was advised that I would need to speak directly with NowThis News about the matter, and she suggested that if I had not received a response from them by the website of website@nowthismedia.com, she recommended I reach out to "Jessica Borovay", who she identified as the Head of Business Operations for NowThis. She provided me with an email address of Jessica.Borovay@nowthismedia.com. I
