Mx. Anderson Aldrich<sup>1</sup>, by and through counsel files this supplement to [D-18] which was filed on January 25, 2023.

- 1. Since the time of the filing of [D-18], counsel has learned that the District Attorney had more or additional professional visitor logs in their possession. See Attached Exhibit A, Professional visits November through January 19, filed suppressed as it contains evidence of attorney-client visits, including the names of the attorneys and agents who visited Mx. Aldrich and the duration of such visits pursuant to C.R.S. § 13-90-107 (1)(b); CRE 502.
- 2. Exhibit A makes it clear that the prosecution is still in violation of the Court's order regarding [D-11], which the prosecution AGREED to be bound by. TR 12/6/21, p 24-26. The request in [D-11], was that the prosecution not be allowed to access the visitor logs. The Court granted that request. The only exception the Court made to [D-11], allowed the DA to possess "incident logs". *Id.* Exhibit A, once again proves the District Attorney is in POSSESSION of professional visitor log for Mx. Aldrich, in violation of the Court's order on [D-11].
