<b>STIPULATION AND ORDER OF PROTECTION PURSUANT TO          C.R.S. § 19-1-114(1)</b>	

1. C.R.S. § 19-1-114(1) gives the court broad power to enter protective orders against parties and specified persons “in assistance of, or as a condition of, any decree” authorized by the Children’s Code.
2. The parties agree that the court will enter the protective order(s) outlined below in order to facilitate the respondent(s) early engagement in assessments and the sharing of information in the assessments prior to determination of adjudication.
3. The parties agree that the respondent, \_\_\_\_\_, will complete a  substance abuse including sobriety monitoring,  domestic violence,  mental health assessment and the information obtained during the evaluation and contained within all resulting reports, including the recommendations, shall not be used in the adjudicatory trial by any party.
4. The protections under C.R.S. 19-3-207 *et seq.* shall apply.
5. The parties agree that the above- mentioned assessment(s) will be distributed to the follow parties or their designees:
  - a. The El Paso County Department of Human Services, including employees and their counsel;
  - b. The *Guardian(s) ad Litem* for the minor child(ren);
  - c. Counsel for the respondent who completed the assessment;
  - d. *Guardian ad Litem* for the respondent who completed the assessment;
  - e. CASA volunteer(s); and
  - f. Treatment professionals, as authorized through a release of information or through court order.

6. Notwithstanding the above, the court shall have access to such records if necessary to resolve any pre-adjudication request made by the respondent(s).
