INITIAL CASE MANAGEMENT ORDER (C-001)	

THIS MATTER comes before the Court sua sponte regarding the filing, identification and labeling of all pleadings in this case.

The Court FINDS AND ORDERS as follows:

Identification and Labeling of Pleadings

1. People's motions must be identified on the first line of the caption with the capital letter P followed by sequential numbering in the order that motions are filed.
Example: P-001

2. Defendant's motions must be identified on the first line of the caption with the capital letter D, followed by sequential numbering in the order that motions are filed.
Example: D-001.

3. Court Orders that are sua sponte or do not otherwise relate to a motion, will be identified on the first line of the caption with the capital letter C, followed by sequential numbering in the order that said orders are filed.
Example: C-001.

4. Dashes and spaces shall be used according to the examples set forth above.

5. The date is not required to appear in the caption of each pleading.

6. Responses and Replies filed by the parties shall use the same lettering and numbering system which appears in the caption of the initiating party's motion.

Example Initial Motion:

P-1

Example Response:

P-001

**DEFENDANT'S RESPONSE TO

Reply to Response:

P-001

**PEOPLE'S REPLY TO DEFENDANT'S RESPONSE TO

The next filing for defense shall be D-008. The next filing by the People shall be P-003.


Filing of Pleadings and Proposed Orders
