She spoke about him in an unprofessional manner, their history, and his election. Now I'm sure all this was true but I thought she worked for the court, not one particular side. My attorneys did this

to make me look like a perjurious individual. Instead it was malfequences on their part. I have included Several reasons to support my claim as I Kept a time kine Of these conflicts.

Communication is broken beyond repair - I explained these issues to Judge Bain including the lack of access and Visitations in complete detail.

Inconsiderate of evidence - Since March 2020, I asked my attorneys to preserve the Gamestop Footage, to located the Taxas Police officer whom I spoke with, and to get the Since passenger list.
