<b>NOTICE TO COURT AND PARTIES OF LETECIA STAUCH'S REFUSAL TO ATTEND LAW LIBRARY AND REQUEST TO BE REMOVED FROM THE LAW LIBRARY SCHEDULE</b>	

The El Paso County Sheriff's Office (EPSO) by and through their undersigned counsel, hereby gives notice to this Court and parties of Defendant, Letecia Stauch's, refusal to attend her scheduled law library time at the El Paso County Criminal Justice Center (CJC) and request to be removed from the law library schedule. In support thereof, EPSO states the following:

1. Letecia Stauch is currently incarcerated in CJC pending trial in the above-captioned case. Ms. Stauch has decided to represent herself in the case.
2. On March 5, 2021, Ms. Stauch completed and signed a Law Library Request Form (Exhibit 1) and was provided a copy of the CJC Law Library Rules (Exhibit 2). The Law Library Rules indicate to that inmates will not select their time to go to the law library and that a refusal to go to the law library will result in the inmate being removed from the law library list for 90 days.
3. On March 30, 2021, Ms. Stauch refused to go to the law library. Ms. Stauch was reminded by CJC personnel that refusal to go to the law library would result in her removal from the law library list for 90 days.
4. On April 2, 2021, Commander Cy Gillespie contacted Ms. Stauch and advised her again of the law library rules. (Exhibit 3). Ms. Stauch again refused to attend the law library during her scheduled time and asked Commander Gillespie to remove her name from the

law library list. On April 8, 2021, Ms. Stauch's name was removed from the law library list for 90 days.

WHEREFORE, EPSO respectfully gives notice to the Court and parties that Defendant, Letecia Stauch has refused to attend the law library at CJC and has asked that her name be removed from the law library list.
