The motion/proposed order attached hereto: DENIED.

I have considered the requests for Expanded Media Coverage filed by KUSA and KDVR/KWGN and the response by the defense as to the KUSA request. Expanded media coverage has been permitted previously on December 31, 2018 and April 5, 2019. This case has received extraordinary media attention. I have considered whether there is a reasonable likelihood that expanded media coverage would interfere with the rights of the parties to a fair trial. I have considered whether expanded media coverage would create adverse effects which would be greater than those caused by traditional media coverage. I have determined that any expanded media coverage of the arraignment on May 24, 2019 would interfere with the rights of the parties to a fair trial and would create adverse effects greater than those caused by traditional media coverage. No expanded media coverage of any type will be permitted. The Motions for Expanded Media are denied .
