The People of the State of Colorado, Daniel H. May, District Attorney for the Fourth Judicial District of Colorado, by and through his duly appointed Lead Deputy District Attorney, Elizabeth Reed, request that Defendant be required to provide discovery of any and all expert witnesses he intends to present such evidence at trial, and as grounds state as follows:

1. “Any report or copy thereof or the findings of the criminalistics laboratory shall be received in evidence in any court, preliminary hearing, or grand jury proceeding in the same manner and with the same force and effect as if the employee or technician of the criminalistics laboratory who accomplished the requested analysis, comparison, or identification had testified in person. Any party may request that such employee or technician testify in person at a criminal trial on behalf of the state before a jury or to the court, by notifying the witness and other party at least ten days before the date of such criminal trial.” C.R.S. 16-3-309(5)
2. The People’s hereby provide notice to the Defendant pursuant to the statute that if Defendant intends to proffer any testimony regarding a laboratory report or analysis performed by any employee or technician of a criminalistics laboratory that the employee or technician who completed the report or analysis must testify in person.
