James C. Ezzell, being first duly sworn on oath, deposes and says: THAT he is a citizen of the United States of America, a resident of LA PLATA County, State of COLORADO, and is the complaining Investigating officer in this action;


THAT on or about the 19th day of NOVEMBER 2012, MARK ALLEN REDWINE, was present in the County of LA PLATA State of COLORADO, and that at that time and place the fugitive committed the crime[s] of: MURDER IN THE SECOND DEGREE, F2, CRS 18-3-103 (1), C.R.S CHILD ABUSE – KNOWINGLY OR RECKLESSLY – RESULTING IN DEATH F2, 18-6-401, (1)(a), (7)(a)(I), C.R.S., in the following manner:

On 11-18-12 Dylan Redwine DOB 2-6-1999, came to La Plata County to visit his father, Mark Allen Redwine, pursuant to a Court ordered visit over the Thanksgiving holiday. Mark Allen Redwine picked up Dylan Redwine from the local airport. They went to Wal-Mart and Mc Donald's and then went to Mark Allen Redwine's home at 2343 CR 500 Bayfield (Vallecito Lake), Colorado. During this visit all of Dylan's communications with family and friends ceased. Mark is the last person to have been with Dylan when Dylan was alive. Dylan's remains have been recovered between about 1.5 miles and 3 miles away from Mark Allen Redwine's home. After an ongoing and lengthy investigation, evidence and case information was presented to a La Plata County Grand Jury on 7-17-2017. After testimony was presented between 7-17-2017 through 7-19-2017, the Grand Jury went into deliberations on 7-20-2017. On 7-20-2017 the Grand Jury returned a True Bill, indicting Mark Allen Redwine for the above attached charges.


THAT thereafter, MARK ALLEN REDWINE left this State and was found in the State of WASHINGTON.

THAT this affidavit is not made for the purpose of enforcing the collection of any debt, or for any private purpose whatsoever, and if the requisition applied for is granted, the criminal proceedings shall not be used for any of these purposes;

THAT MARK ALLEN REDWINE is a fugitive from the justice of this state, was arrested on 7-21-2017 at 11:43pm and is now located in the City of Bellingham, County of Whatcom, State of Washington.
