Second Updated Redwine Jury Trial Procedure for the Trial Scheduled June 2021		

Due to the current state of new COVID-19 infections, vaccination rates, and COVID-19 test positivity rates in La Plata County, and considering all applicable executive and public health orders, the Court is again changing the procedures that will be used during Mr. Redwine's trial scheduled to begin on June 14, 2021.

- a. The provisions of Administrative Ordered 2021-12 shall apply and Admin order 2021-12 shall control the wearing of facial coverings and social distancing in the courtroom. The well and public seating area of the courtroom will be marked to designate seating for members of the venire, members of the public and for the jury with appropriate social distancing.
- b. The entire trial, with the exceptions stated below will be streamed on the internet via Webex Events. Counsel, the defendant and members of each litigation should remember that the microphones in the courtroom will be on throughout the entire trial and unless microphones are muted, conversations at counsel table, the lectern or near other microphones are likely to be heard by anyone streaming the trial.
- c. Starting Monday June 14<sup>th</sup>, through Tuesday June 22<sup>nd</sup>, the jury commissioner will call three waves of venire large enough for 33 jurors in each wave. The jurors will be called at 8:00AM, 11:00AM and 2:30 PM. For each wave, the Court will conduct its voir dire in division 4 and upon completing its voir dire give the remaining members of the venire a questionnaire who will be excused upon its completion. Upon being excused, each member of the remaining venire shall be assigned a number, told when to return for individual voir dire and provide the bailiff contact information. The audio portion only of jury selection proceedings in Division 4 shall be broadcast via Webex and will be available for the public to observe. If by Wednesday, June 16<sup>th</sup>, 56 or more members of the venire remain, the Court shall begin individual voir dire on Thursday, June 17<sup>th</sup>.

If insufficient members of the venire remain as of June 16<sup>th</sup>, the Court shall continue its voir dire of the venire until a sufficient number of the venire remain to begin individual voir dire.

d. Individual voir dire shall be held in division 4 with the bailiffs to stage jurors outside of the courtroom until each is needed. Due to the personal nature and purpose of individual voir dire, individual voir dire shall be closed to the public and shall not be broadcast via Webex. Individual voir dire shall be limited to 5 minutes per juror per side, with the individual questioning being limited to the juror's responses, or lack of responses on their questionnaire.

e. After individual voir dire, the bailiff shall randomly assign numbers to the jurors who remain. The first 44 shall be called for the voir dire of the attorneys starting

at 8:00 AM on Monday June 21st and sit in the seat number which corresponds to the number previously assigned to them by the bailiff. The next 44 jurors shall report to the courthouse at 1:00 PM on Monday, June 21st. Any remaining iurors will be held in reserve and called and directed to report to the courthouse, if needed. Counsel shall be limited to 75-minute voir dire as to jurors numbered 1-37. If 28 or more jurors remain after both sides have completed their voir dire of jurors numbered 1-37, the parties shall exercise their preemptory challenges. If less than 28 members of the venire remain the Court will give the parties additional time to voir dire the remaining 7 members of the venire in the courtroom and if sufficient jurors remain, the parties shall then exercise their preemptory challenges. If less than 28 members of the venire remain after the parties have competed their voir dire of jurors numbered 1-44, the jury panel will be dismissed until a time set by the Court and the parties general voir dire will continue with the 1:00 panel. The new panel will sit in the order of the numbers previously assigned them by the bailiff. Depending upon the number of jurors needed, the Court may place appropriate time limits on counsel for voir dire with this second panel.

- f. Counsel should be prepared for opening statements and the start of testimony on the afternoon of June 21, 2021.
- g. All exhibits will be marked with an exhibit number and the case number prior to the presentation of evidence. Both sides shall provide the court with an exhibit book containing pre-marked proposed exhibits prior to the presentation of evidence. The defense exhibit book will remain confidential and not shared with the prosecution. Exhibits to be shown to the jury will, to the extent possible, be displayed electronically as it is introduced. Counsel shall ensure that they are able to connect to the Court's video screen prior to the beginning of the presentation of evidence. Hard copies of the exhibits shall be given to the Court to allow the bailiff to place in the juror notebooks during recesses. All juror notebook copies of Exhibits will be three hole punched.
