NOTICE REGARDING REPORT FROM COLORADO MENTAL HEALTH INSTITUTE AT PUEBLO (C-57)	

On June 4, 2013, the Court accepted the defendant's plea of not guilty by reason of insanity and ordered the Colorado Mental Health Institute at Pueblo ("CMHIP") to conduct a sanity examination and prepare a report. The Court initially ordered CMHIP to submit its report by July 31, 2013, but the Court later granted CMHIP's request for an extension of the deadline until September 16, 2013. 
Earlier today, at approximately 4:17 p.m., the Court received an encrypted, electronic copy of CMHIP's 128-page report (including attachments) and an encrypted, electronic copy of a cover letter (hereafter collectively "the report"). Colorado law requires the Court to "furnish a copy of the report both to the prosecuting attorney and the counsel for the defendant." § 16-8-106(4), C.R.S.

(2012). Accordingly, the Court has printed the report and has made two copies, one for each party, and has placed each copy in a confidential envelope. One of the attorneys of record for each party may pick up a copy of the report in person before 6:00 p.m. today from Laurie McKager, the Judicial District's Administrator, or from the Clerk of the Court, Tammy Herivel, at any time after 9:30 a.m. on Monday, Tuesday, or Wednesday of next week. The parties may also pick up their copy of the report from Julie Rost, a member of the Clerk's Office, on Thursday or Friday of next week before 3:00 p.m. The attorneys of record picking up the copies of the report will be required to provide photo identification.

The original report is hereby suppressed. It will be kept in a confidential, sealed envelope until further order by the Court.
