ORDER REGARDING PEOPLE’S REQUEST FOR CLARIFICATION OF ORDER D-245-B (P-95)	

On October 27, the Court issued Order D-245-B, continuing the trial at the defendant’s request from December 8 to January 20. *See* Order D-245-B at p. 6. In the same Order, the Court postponed the pretrial status hearing from November 3 to December 8. *Id.* The prosecution seeks clarification of Order D-245-B. Motion at p. 1.¹ The request is granted.

In Order D-245-B, the Court identified the three specific issues it intends to address at the November 3 hearing. *See* Order D-245-B at p. 6. The Court then explained that all of the other issues scheduled to be discussed on November 3

would be addressed on December 8. *Id.* The prosecution asks the Court to clarify whether the deadlines set for November 3 are extended to December 8. The deadlines set for November 3 have been extended until December 8. Motion at p. 2. However, any deadlines that had already expired when the Court issued Order D-245-B continue to be expired. In other words, Order D-245-B does not resuscitate any expired deadlines.
