<b>ORDER SUPPRESSING RESPONSES AND REPLIES RELATED TO          DEFENSE MOTIONS D-186a, D-188a, D-246, AND D-247 (C-160)</b>	

On November 7, 2014, the prosecution filed its responses to Motions D-186a, D-188a, D-246, D-247, and D-250. Yesterday, the defendant filed his replies in support of those motions. At the defendant's request, the Court suppressed Motions D-186a, D-188a, D-246, D-247, and D-250. Order C-158 at p. 2. The Court finds that Order D-250 and the response and reply filed in connection with Motion D-250 need not be suppressed, and that the public copies of those documents should not be redacted.<sup>1</sup> Additionally, the Court concludes that there is no reason to conceal any part of the title of Motion D-250.<sup>2</sup> The Court does

<sup>1</sup> The prosecution does not seek to have its response to Motion D-250 suppressed. Nor does it ask the Court to make any redactions to the public copy of that response.

<sup>2</sup> The Court had previously redacted part of the title of Motion D-250. *See* Order C-158 at p. 2 n.1. That part of Order C-158 is hereby modified.

suppress the responses and replies filed with respect to Motions D-186a, D-188a, D-246, and D-247. Further, consistent with Order C-158, the Court redacts the caption of the public copies of the response and reply filed regarding Motion D-247. *See id.* at p. 2 n.1. The caption of the public copy of Order D-247 is likewise redacted.


