ORDER ADDRESSING PROSECUTION'S NOTIFICATION REGARDING POTENTIAL JURORS (P-106)	

This matter is before the Court on the prosecution's notification regarding potential jurors.¹ The prosecution informs the Court that twelve of its endorsed witnesses received jury summonses for this case. Motion at pp. 1-2. The parties jointly ask the Court to excuse these individuals from their jury summonses. *Id.* at p. 2. That request is granted. The prosecution's request to notify these individuals that they have been excused from their jury summonses, which also appears to be unopposed, *see id.*, is likewise granted.

The prosecution further advises that one of the prospective jurors in this case is a compensated member of its office. *Id.* The parties jointly ask the Court to

¹ Although the prosecution asks the Court to suppress Pleading P-106, the Court declines to do so because it appears that what the prosecution meant to request is the suppression of the names of prospective jurors included in the pleading. The Court will disclose to the public only the redacted version of Pleading P-106, which conceals such names.

excuse this prospective juror from her jury summons. *Id.* That request is granted. The prosecution's request to notify this individual that she has been excused from her jury summons, which also appears to be unopposed, *see id.*, is granted as well.

The prosecution lists seven other prospective jurors who have either familial relationships or friendships with a compensated employee of the prosecution's office or an endorsed prosecution witness. *Id.* at pp. 2-3. Because neither party asks the Court to take any action with respect to these individuals, the Court refrains from doing so at this time.

Finally, the prosecution includes a list of prospective jurors who have "the same names as endorsed prosecution witnesses." *Id.* at pp. 3-4. The Court appreciates this information. If the prosecution determines that any of these individuals is actually endorsed as a prosecution witness and must be excused from his or her jury summons, it should file another notification.
