TO ANY JUDGE OF THE STATE OF [REDACTED]:

I, Carlos Samour, Chief Judge of the District Court, Eighteenth Judicial District, in and for the County of Arapahoe, State of Colorado, a court of record, do hereby certify as follows:

1. That the above-captioned case in Arapahoe County, State of Colorado, is presently set for Trial on April 27, 2015.
2. That although the District Attorney would like to have [REDACTED] return voluntarily to testify as a witness in the above-captioned matter, he may refuse to do so.
3. That [REDACTED] is believed to be residing at [REDACTED]

4. That [REDACTED] is a material witness in this prosecution in that [REDACTED] testimony is necessary and material to authenticate records and purchases related to the commission of the crimes charged in this case.
5. That [REDACTED] will be called as a witness before this Court in the State of Colorado, on or about May 11, 2015, at 8:30 a.m.. [REDACTED] will be required to travel from [REDACTED] to Centennial, Colorado, and back, requiring a total maximum travel time of one day, one way; the presence of [REDACTED] as a witness will be required before said Court for a minimum of one day and will remain until released by the Court.
6. That if [REDACTED] comes into Colorado in obedience to an order directing him to attend and testify at said Trial on or about May 11, 2015, the laws of the State of Colorado give him protection from arrest or service of process, either civil or criminal, in connection with matters which arose before his entrance into the State of Colorado pursuant to said order. Section 16-9-204, C.R.S., as amended.
7. That [REDACTED] would not experience undue hardship in being compelled to appear and testify in said Colorado Court.
8. Payments of \$20.00 per day will be tendered as required by law to [REDACTED] on a daily basis if he is required to remain in Colorado as a witness in this case for longer than one day. Round-trip transportation will be provided, and transportation and lodging information will be forwarded to [REDACTED].

WHEREFORE, pursuant to the provisions of Section 16-9-203, C.R.S., I respectfully request that a Judge of a Court of Record of [REDACTED], order [REDACTED] [REDACTED] to appear in said Court for a hearing on my request, which I now make, that [REDACTED] be compelled to appear and testify in the

Trial of the above-captioned matter at 7325 South Potomac Street, Centennial, Colorado, on or about May 11, 2015 and will remain until released by the Court.
