HOLMES DURING SECOND SANITY EXAMINATION AND          TO REDACT THEM FROM ANY VIDEO RECORDING OF THE          SECOND SANITY EXAMINATION INTRODUCED INTO EVIDENCE          (D-264a-3)</b>	

**INTRODUCTION**

This matter is before the Court on the defendant’s motion to suppress and/or exclude and redact certain exchanges he had with Dr. William Reid during the second Court-ordered sanity examination, which was video recorded. Motion at p. 1.<sup>1</sup> The prosecution opposes the motion. *See generally* Response. For the reasons articulated in this Order, the motion is granted in part and denied in part.


**CONCLUSION**

For all the foregoing reasons, the Court finds that Motion D-264a has some merit. Accordingly, it is granted in part and denied in part.

The exclusions and redactions required by this Order relate only to the guilt phase of the trial. Excluded and redacted evidence may nevertheless be admissible at a sentencing hearing. Further, to the extent the Court grants the motion, the evidence excluded or redacted may become admissible if the defense opens the door during the guilt phase of the trial. Therefore, the defense must proceed with caution.
