PROSPECTIVE JURORS 6083 AND 227 ARE EXCUSED BY STIPULATION OF THE PARTIES BASED ON EMAILS THEY SENT TO THE JURY COMMISSIONER'S OFFICE. THE COURT GRANTS THE DEFENSES REQUEST FOR COPIES OF ANY CRIMINAL HISTORIES OBTAINED BY THE PEOPLE ON PROSPECTIVE JURORS. THE COURT RULES THAT, TO THE EXTENT THE PROSECUTION IS ABLE TO OBTAIN CRIMINAL HISTORIES ON PROSPECTIVE JURORS THAT ARE NOT AVAILABLE TO THE DEFENSE AT NO COST, THE PROSECUTION MUST

DISCOVER THOSE TO THE DEFENSE. THE DEFENSE WILL PAY THE PEOPLE FOR THE COSTS FOR THE COPIES AT WHATEVER RATE IT WOULD NORMALLY PAY FOR DISCOVERY.

THE COURT CONDUCTS VOIR DIRE WITH THE GROUP OF FOUR PROSPECTIVE JURORS WHO APPEARED THIS MORNING.

THE COURT AND THE PARTIES CONDUCT INDIVIDUAL VOIR DIRE ON PROSPECTIVE JUROR 113. WITHOUT OBJECTION, PROSPECTIVE JUROR 113 IS ASKED TO RETURN FOR GROUP VOIR DIRE. THE COURT CONDUCTS INDIVIDUAL VOIR DIRE ON PROSPECTIVE JURORS 49, 161, AND 164 AND THE PARTIES STIPULATE TO EXCUSE THOSE THREE PROSPECTIVE JURORS.

### AFTERNOON SESSION:

THE COURT AND THE PARTIES CONDUCT INDIVIDUAL VOIR DIRE. WITHOUT OBJECTION, PROSPECTIVE JUROR 167 IS ASKED TO RETURN FOR GROUP VOIR DIRE. PROSPECTIVE JURORS 169 AND 176 ARE QUALIFIED FOR GROUP VOIR DIRE OVER THE DEFENSE'S OBJECTION. PROSPECTIVE JURORS 177 AND

GROUP VOIR DIRE OVER THE DEFENSE'S OBJECTION. PROSPECTIVE JURORS 177 AND 295 ARE RELEASED BY STIPULATION OF THE PARTIES. PROSPECTIVE JUROR 172 IS TEMPORARILY RELEASED SO SHE CAN FOLLOW UP WITH HER EMPLOYER REGARDING COMPENSATION DURING JURY DUTY.
